

ORDINANCE 85-27

To Amend Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic"

WHEREAS, The Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic":

NOW, THEREFORE, BE IT HEREBY ORDAINED By the Common Council of the City of Bloomington, Monroe County, Indiana:

Section I. Section 15.20.020 Schedule H shall be amended to delete the following:

RESTRICTED TURNS ON RED AT SIGNALIZED INTERSECTIONS

<u>Intersection</u>	<u>From</u>	<u>To</u>
Rogers Street & Second Street	West	South
Second Street & Walnut Street	East	North

Section II. Section 15.20.020 Schedule H shall be amended to add the following:

<u>Intersection</u>	<u>From</u>	<u>To</u>
Hillside and Walnut Street	East	North

Section III. Section 15.32.090 Schedule N shall be amended to read, for the second Lincoln Street entry, as follows:

LIMITED PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Limit</u>
Lincoln Street	Smith St.	1st alley So. of Third St.	East	2 Hr.

Section IV. Section 15.32.080 Schedule M shall be amended to add the following:

NO PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Limit</u>
Covenanter St.	450' East of Auto Mall Rd.	1200' East of Auto Mall Road	Both	Anytime

Section V. Section 15.32.100 Schedule O shall be amended to add the following:

LOADING ZONES

418 S. Walnut, west side of the street from 7 a.m. to 7 p.m.

Section VI. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.

Section VII. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This Ordinance makes the following changes in Title 15 "Vehicles and Traffic" of the Municipal Code: deletes two "No Turn on Red" restrictions and adds one restriction for westbound traffic on Hillside Drive at Walnut Street; changes the two 30-minute parking restrictions adjacent to 351 S. Lincoln to 2-hour parking; adds a no-parking restriction on Covenant Drive; and adds a loading zone at 418 S. Walnut Street.
