

ORDINANCE 85-38

To Amend Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic"

WHEREAS, the Bloomington Traffic Commission has recommended that certain changes be made in Title 15 of the Municipal Code entitled "Vehicles and Traffic":

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 Stop Intersections Schedule B shall be amended to add the following:

MULTI-STOP INTERSECTIONS

Third Street (Westbound) & Jackson Street 3-way

SECTION II. Section 15.12.030 Signalized Intersections Schedule D shall be amended to add the following:

SIGNALIZED INTERSECTIONS

Third Street & Woodscrest-Hillsdale

SECTION III. Section 15.20.020 Restricted turns on red at signalized intersections Schedule H shall be amended to add the following:

RESTRICTED TURNS ON RED

<u>Intersection</u>	<u>From</u>	<u>To</u>
Third Street & Hillsdale	East	North
Third Street & Woodscrest	West	South

SECTION IV. Section 15.32.080 No Parking Zones Schedule M shall be amended to delete the following:


NO PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Time</u>
Third St.	Jackson St.	1st Alley East of Walnut St.	South	Anytime
Third St.	Rogers St.	1st Alley East of Walnut St.	South	Anytime
Fairview St.	11th St.	13th St.	East	Anytime

Section V. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.

Section VI. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This ordinance makes the following changes in Title 15 "Vehicles and Traffic" of the Bloomington Municipal Code: adds a multi-stop intersection at Third and Jackson, adds a traffic signal at Third Street and Woodscrest-Hillsdale as well as the appropriate NO TURN ON RED signage, eliminates a no parking zone on Third Street between Rogers Street and Jackson, and creates a no parking zone on Fairview Street between 11th and 13th Streets.
