ORDINANCE 85 - 46
To Vacate a Public Parcel

(2301 S. Rogers Street - Claude Sluder)

SECTION I. Through the authority of IC 36-7-3-12, a portion of City-owned property at 2301 S. Rogers Street shall be vacated. property is more particularly described as follows:

Beginning at the Northwest corner of Broadview Second Addition to the City of Bloomingtokn, said point being on the east right of way of Rogers Street, then East 132 feet by parallel line 12 feet off the North boundary of Lot 1, Broadview Second Addition.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor, and published according to law.
