

ORDINANCE 85-68

TO AMEND THE 1986 SALARY ORDINANCE FOR APPOINTED OFFICERS AND EMPLOYEES
OF THE CITY OF BLOOMINGTON TO BRING THE ORDINANCE INTO
COMPLIANCE WITH THE FAIR LABOR STANDARDS ACT

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,
MONROE COUNTY, INDIANA THAT:
