

ORDINANCE 84-5

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE TO ADD A BUS ZONE, A NO PARKING ZONE, A LIMITED PARKING ZONE, AND TO PROVIDE FOR DUPLICATE CLASS A PARKING PERMITS

WHEREAS, the Bloomington Traffic Commission, the City Engineer, and the City Legal Department, have recommended certain changes in Title 15 entitled "Vehicles and Traffic",

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.32.110, Schedule P, Bus Zones, shall be amended to add the following:

<u>STREET</u>	<u>FROM</u>	<u>TO</u>	<u>SIDE OF STREET</u>
Sixth St.	Elm Street	50' W. of Elm St.	South

SECTION II. Section 15.32.080, Schedule M, No Parking Zones, shall be amended to add the following;

<u>STREET</u>	<u>FROM</u>	<u>TO</u>	<u>SIDE OF STREET</u>	<u>TIME OF RESTRICTION</u>
Madison	Third Street	85' N. of Third St.	West	Anytime

SECTION III. Section 15.32.090 Limited Parking Zones, Schedule N, shall be amended to delete the following:

<u>STREET</u>	<u>FROM</u>	<u>TO</u>	<u>SIDE OF STREET</u>	<u>LIMIT</u>
Washington	Seventh St.	Eighth St.	East	15 min. (2)

and to add the following:

Washington	Seventh St.	Eighth St.	West	15 min. (2)

SECTION IV. Section 15.40.030 Annual Parking Permits (a) shall be amended to read as follows:

(a) The city will issue two types of annual parking permits. A limited number of annual parking leases, hereafter referred to as Class A permits (not to exceed 25% of the available spaces) for specific spaces on the lower level of the Municipal Parking Garage are available. The charge for such spaces shall be two hundred dollars per year. In addition, unlimited duplicate Class A permits shall be available to a Class A permit holder at \$ 5.00 per permit; each duplicate permit shall allow the permit holder to park an additional designated vehicle in the original Class A permit holder's specific designated stall only. No duplicate Class A permit-bearing vehicle may park in any other space or in any other lot, without proper permit for such lot. Only motor vehicles displaying a Class A permit or duplicate permit for that stall may park in a leased stall. Any car illegally parked in a leased stall shall be both ticketed and immediately towed.

SECTION V. Section 15.40.050 (b) Violations shall be amended to read as follows:

(b) No person shall park in a leased stall in the Municipal Parking Garage without a Class A permit sticker or duplicate sticker displayed in the lower right hand corner of the windshield of the vehicle.

SECTION VI. Severability. If any section of this ordinance or any part of any section shall be declared invalid or unconstitutional such declaration shall not affect the validity or constitutionality of the remaining portions.

SECTION VII. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.

SYNOPSIS

This ordinance amends Title 15 of the Bloomington Municipal Code to add a Bus Zone, a No Parking Zone and Limited Parking Zone at the request of the Traffic Commission and amends the Parking Permit provisions of Title 15 to provide that an unlimited number of duplicate Class A parking permits may be purchased by a Class A permit holder for \$ 5.00 each; such permit will allow designated additional vehicles to park in the permit holder's leased space only.
