

To Vacate a Public Parcel

re: Block bounded by Smith, Dunn, Atwater, and Henderson (Dr. Richard Shelly)

WHEREAS, IC 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner, DR. RICHARD SHELLY, has filed a petition to vacate two parcels of City property in the block bounded by Smith, Dunn, Atwater, and Henderson; and

WHEREAS, IC 36-7-3-512 requires the Plan Commission to make a recommendation on the proposed vacation and to forward it to the Common Council; and

WHEREAS, the Plan Commission has considered this petition and made a favorable recommendation on its adoption;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-3-12, a portion of City-owned property in the block bounded by Smith, Dunn, Atwater, and Henderson shall be vacated. The property is more particularly described as follows:

A part of Louden's Addition to the City of Bloomington, as recorded in Plat Book 1, Page 30 in the Office of the Recorder of Monroe County, Indiana and more particularly described as follows: The ten foot alley lying East to West between Lots 3, 4, and 5 to the South and Lot 12 to the North of the aforesaid Louden's Addition containing 1400 square feet, more or less.

A part of Louden's Addition to the City of Bloomington, as recorded in Plat Book 1, Page 30 in the Office of the Recorder of Monroe County, Indiana, and more particularly described as follows: The twelve foot alley lying North to South between Lot 3 to the West and Lot 2 to the East of the aforesaid Louden's Addition containing 1300 square feet more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor, and published according to law.


