WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual budget;



SECTION I. For the expenses of said municipal corporation the following additional sums of money are hereby appropriated and ordered set apart from the fund herein named and for the purpose herein specified, subject to the laws governing the same;


SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.





SYNOPSIS

Additional funds are needed for Rogers Street Bridge project soil testing, Smith Road Underpass construction engineering and right-of-way acquisition, small scale drainage improvements at Winslow and Henderson, West Fifth Street, and Seventh and Morton Streets, and Smith Road Underpass gas line relocation. A total of \$ 111,771.00 will be reimbursed with Federal grant funds.
