

ORDINANCE 83-34

AN ORDINANCE CONCERNING THE VOLUNTARY ANNEXATION OF CONTIGUOUS TERRITORY

WHEREAS, the boundary of the City of Bloomington is contiguous to the real estate described herein, and

WHEREAS, on June 20, 1983 a Petition for Annexation of the real estate described herein was filed by the owners of said real estate, requesting annexation of the area pursuant to IC 36-4-3-5;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. The following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Monroe County, Indiana, to-wit:

A part of the Northeast quarter of Section 32, Township 9 North, range 1 West, Monroe County, Indiana, bounded and described as follows: Beginning at a point that is 1033.00 feet East of the Northwest corner of said quarter in said Section 32, thence running East for 100.00 feet; thence South 00 degrees 38 minutes West for 300.00 feet, thence West for 100.00 feet; thence North 00 degrees 38 minutes East for 300.00 feet and to the point of beginning. Containing in all 0.69 acres more or less.

SECTION II. Be it further ordained that the boundaries of the City of Bloomington shall be and the same hereby are, declared extended to include all of the real estate herein above described as part of the City of Bloomington, Monroe County, Indiana.

SECTION III. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.

Comes now Willowbrook Partners, Ltd., an Indiana Limited Partnership, by Real Estate Problem Solvers, general partner, an Indiana partnership, and petitions the Bloomington Common Council to annex approximately 0.69 acres of land, described as follows:

A part of the Northeast quarter of Section 32, Township 9 North, Range 1 West, Monroe County, Indiana, bounded and described as follows: Beginning at a point that is 1033.00 feet East of the Northwest corner of said quarter in said Section 32, thence running East for 100.00 feet; thence South 00 degrees 338 minutes West for 100.00 feet; thence North 00 degrees 38 minutes East for 300.00 feet and to the point of beginning. Containing in all 0.69 acres more or less.

The total border of this land is 800 feet, of which 300 feet are contiguous with the City's corporate boundaries. Therefore, 26.6% of the borders of the proposed annexation is contiguous with the City's corporate boundaries.

Willowbrook Partners, Ltd. is the sole owner of the real estate in question.

WHEREFORE, pursuant to I. C. 36-4-3-5, said owners request an ordinance annexing the area described herein.
