To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, ZO/DP-46-83, and recommended that the petitioner, Real Estate Problem Solvers, be granted an amendment to the Bloomington Zoning Maps and request that the Common Council consider their petition for rezoning of certain property:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 that the zoning be changed from BA to RH for property located at 17th Street west of Maple more particularly described as follows:

A part of the Northeast quarter of Section 32, Township 9 North, Range 1 West, Monroe County, Indiana, bounded and described as follows: Beginning at a point that is 1,033.00 feet East of the Northwest Corner of said quarter in said Section 32, thence running East for 100.00 feet; thence South 00 degrees 38 minutes West for 110.00 feet and to the true point of beginning; thence continuing South 00 degrees 38 minutes West for 190.00 feet; thence West for 100.00 feet; thence North 00 degrees 38 minutes East for 190 feet; thence East for 100 feet and to the true point of beginning. Containing .43 acres more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
