### Recommendations of Mayor for Distribution of Community Development Funds (Jobs Bill)

WHEREAS, the City of Bloomington, Indiana, is eligible for Community Development Block Grant funds in the amount of \$377,000.00 for fiscal year 1983 pursuant to the Housing and Community Development Act of 1974, as amended, and

WHEREAS, the national objectives of the program are as follows:

- The primary objective of the Community Development Program is the development of viable urban communities, including decent housing and a suitable living environment and expanding economic opportunities principally for persons of low and moderate income.
- 2. The elimination of slums and blight and the prevention of blighting influences and the deterioration of property and neighborhood and community facilities of importance to the welfare of the community, principally to persons of low and moderate income;
- 3. The elimination of conditions which are detrimental to health, safety, and public welfare, through code enforcement, demolition, interim rehabilitation assistance, and related activities;
- 4. The conservation and expansion of the Nation's housing stock in order to provide a decent home and suitable living environment for all persons, but principally those of low and moderate income;
- 5. The expansion and improvement of the quantity and quality of community services, principally for persons of low and moderate income, which are essential for sound community development and for the development of viable urban communities; and
- 6. The reduction of the isolation of income groups within communities and geographical areas and the promotion of an increase in the diversity and vitality of neighborhoods through the spatial deconcentration of housing opportunities for persons of lower income and the revitalization of deteriorating or deteriorated neighborhoods to attract persons of higher income; and
- 7. The alleviation of physical and economic distress through the stimulation of private investment and community revitalization.

WHEREAS, a proposed statement of community development objectives and projected use of funds has been advertized, and

WHEREAS, said statement and projected use of funds reflect programs recommended by the Mayor with input from the Workable Program Committee and the Redevelopment Commission consistent with local and national objectives of the Housing and Community Development Act of 1974, as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, THAT:

# SYNOPSIS

This resolution outlines programs recommended for funding by the Mayor with input from the Workable Program Committee and the Redevelopment Commission. General program areas include Public Service Programs and Site Improvement Programs.

The request of the Area 10 Agency on Aging is to provide funding to establish a program to teach job finding techniques to the elderly. The Workable Program Committee considers the program to be a duplication of efforts that can be better provided by other agencies that have more experience and expertise in the delivery of proposed services.

In conjunction with that increase the recommendation is that the coordinator position be increased from 3/8 time to 1/2 time for a period of nine months and that a "Job Developer" position be added to assist in the placement of clients. As a condition of funding the Workable Program Committee recommends that the agency coordinate its efforts with Channel 3, Monroe County Library. The agency agreed in presentation to develop a component for the elderly. It is recommended that the agency also

The Workable Program Committee recognizes that the program provides services for correction of deficiencies of a segment of population which is chronically unemployed. The agency has made significant progress in developing an accounting system which will comply with CDBG requirements. It is recommended that the program be fully funded but closely monitored.

The proposal is to provide specialized services in the training and placement for employment of a targeted population. The constituency requires a more sheltered orientation to re-entering the work force. Funding is recommended at \$4093.00, deleting indirect costs as ineligible under CDBG guidelines.

The program has an assurance from the Monroe County School Corporation that support in the provision of staffing will be available subject to a demonstration of community support and funding is available. The program seeks to improve employment opportunities for a youth population that predictably will experience greater problems in finding employment if the alternative school program discontinues.

9. Agency Request Recommendation Better Living for Special People Group Home \$15,450.00 \$ -0-

The group addresses the personal needs of a special population which is chronically unemployed, a factor in the total unemployment situation. It is the Workable Program Committee's determination that the group is not in a position to effectively utilize CDBG funds at this time given dollar needs and lack of other funding.

The Workable Program Committee recommends assistance at a level of \$40,000.00 in the form of a deferred low-interest loan subject to receipt of the Historic Preservation funds and accomplishment of identified improvements.

The proposal received was to provide local match funding for UPARR funds through the Department of Parks and Recreation. Funds will be used to upgrade Building Trades Park, Westside Community Center Playground and West Ninth Street Park. The projects, if completed, will significantly upgrade neighborhood parks on the westside and generate \$115,000.00 in additional funds from UPARR. Workable Program Committee recommends full funding.

Funding for Phase II was included for the widening and reconstruction of Diamond Street and portions of West Cottage Grove from its intersection with West 10th Street. Phase III will include the widening of Cottage Grove from that intersection to Monroe Street resulting in a 24' street with curb and gutter.

6. <u>Agency</u> Recommendation Request Highland Avenue Reconstruction Phase II \$99,000.00 \$ -0-

Phase I of Highland Reconstruction between Miller Drive and Short Street is presently under construction and involves drainage improvements at the intersection of Miller Drive and Highland and to the west side of Highland. Phase II involves the complete reconstruction of Highland between Miller Drive and Thornton Avenue. Phase III includes widening of Highland between Short and Miller, a five foot sidewalk on the east side of Highland, and necessary drainage improvements along the east side. It is anticipated that Phase II may be completed with reprogrammed CD VII funds. Phase III is seen as a higher priority for Jobs Bill funds since the pavement condition is much poorer. Therefore, no funding is recommended for Phase II from Jobs Bill funds.

Phase II Reconstruction of Highland between Miller Drive and Thornton is fully designed and all right-of-way has been acquired. The pavement condition is very poor. Accordingly, full funding is recommended.

The Redevelopment Commission enters into a funding agreement with the Adult Education Program to provide unemployed or under-employed residents of the City of Bloomington with job-seeking skills; specifically, access to career and job counseling services, conducting workshops, and the provision of support-services for job-hunting.

2. <u>Displaced Homemakers Project</u> Human Resources Department \$2,000.00

A funding agreement between the Redevelopment Commission and the Human Resources Department, City of Bloomington, is entered into to provide career exploration and planning, job readiness training and employment referrals to displaced homemakers entering or re-entering the labor market. The program is specifically designed to assist men and women who have lost financial security because of death, divorce, desertion or separation from a spouse upon whom they had been previously dependent.

3. <u>Community Job Information</u> Monroe County Public Library

> A funding agreement between the Redevelopment Commission and Channel 3, Monroe County Public Library is entered into to produce television programs and videotape series, providing information on local employment and technical job-seeking skills and techniques (in cooperation with other local agencies and organizations).

7. Alternative High School Monroe County Community School Corporation

The Redevelopment Commission enters into a funding agreement with the Monroe County Community School Corporation for the provision of an alternative educational program for low-income students.

8. Princess Theatre Thomas Canada

> Funding is recommended in the form of a deferred low-interest loan, subject to receipt of other funds and accomplishment of identified improvements, to match grants to upgrade the building for use as a community arts center.

9. UPARR Parks and Recreation

> Funds provide local match funding for UPARR funds through the Department of Parks and Recreation. Funds will be used to upgrade Building Trades Park, Westside Community Center Playground and W. Ninth St. Park.

10. Crestmont Parking Lot Bloomington Housing Authority

> Funding is recommended to replace portions of one of the parking lots areas at the Crestmont Housing Authority Project.

11. Small Scale Drainage

> Small Scale Drainage improvement programs include Tenth and Dunn; Sixth and Ritter, Eighth and Rogers; and 200 Grimes Lane.

12. West Cottage Grove, Phase III

Phase III of the West Cottage Grove Project includes the widening of Cottage Grove from the intersection of Diamond St. and West Cottage Grove to Monroe St., resulting in a 24' street with curb and gutter.

13. Highland Ave. Phase II

> Phase II Reconstruction of Highland between Miller Drive and Thornton is fully designed and all right-of-way acquired. Funding is recommended for the widening and paving of the street and to aggregate shoulders, to provide an incentive for development in this area.
