ORDINANCE 82-1

To Repeal and Re-enact Title 15 of the Bloomington Municipal Code, Entitled "Vehicles and Traffic" and to Repeal Certain Sections of Title 12, Entitled "Streets, Sidewalks, Storm Sewers" and Section 18.04.120, Entitled "Parking Adjacent to Building.

WHEREAS, a 1981 survey on traffic signal and sign modernization by a professional consulting engineering firm, funded by federal highway funds has resulted in an up-to-date list of signed parking regulations as they exist on Bloomington streets and parking

WHEREAS, IC 9-4-1-27 and IC 36-1-3-8(7) and (8) prohibit a municipality from duplicating provisions of state statutes and some duplication exists in the current municipal code, and

WHEREAS, IC 9-4-1-27(b) permits local governments to alter by ordinance state speed limits on streets under local jurisdiction,

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Title 15 of the Bloomington Municipal Code shall be repealed and re-enacted to read as follows:

15.04.010 Definitions generally. (a) Terms used in this title shall have the meanings defined for such terms by the Indiana Statutes, Title 9, "Motor Vehi:les", unless specifically provided otherwise.

(b) Any reference in this title to a specific street, avenue or drive shall be deemed to be a reference to the exact and correct name of such street so long as the first part of the name before the word "street", "avenue", or "drive", as the case may be, is correctly stated.

15.04.020 Abandoned vehicle. "Abandoned vehicle" means:

(1) a vehicle located on public property illegally;

a vehicle left on public property continuously without being moved

for three days;
(3) a vehicle that has remained on private property without the consent of the owner or person in control of that property for more than forty-eight hours;

(4) a vehicle from which there has been removed the engine, transmission, or differential or that is otherwise partially dismantled or inoperable

and left on public property;
(5) a vehicle that has been removed by an authorized towing service upon request of an officer enforcing a statute or ordinance other than chapter 15.52, if the vehicle once impounded is not claimed or redeemed by the owner or his agent within fifteen days of its removal; or

a vehicle that is six or more model years old and mechanically inoperable, and is left on private property continuously in a location visible from public property for more than thirty days.

15.04.030 Alley. "Alley" means a public wat the rear or side of residences or businesses. "Alley" means a public way for vehicular travel located

15.04.040 Authorized towing service. "Authorized towing service" means a business that engages in moving or removing disabled vehicles, and, once removed, to store or impound vehicles, and that has been requested by the Bloomington police department to tow vehicles.

15.04.050 Automobile scrapyard. "Automobile scrapyard" means a business organized for the purpose of scrap metal processing, automobile wrecking, or operating a junkyard.

15.04.060 Officer. "Officer" means every officer of the Bloomington Police Department and any other duly constituted law officer who may be aiding the Bloomington Police Department at any time, including state and county officers.

15.04.070 Parked. "Parked" means, when prohibited, any vehicle that is standing, stopped, or parked, whether occupied or not.

15.04.080 Parking meter. "Parking meter" means a device which indicates the length of time during which a vehicle may be parked in a particular place which has as a part a receptable or chamber for receiving and storing coins, and a slot or place in which coins may be deposited; a timing mechanism to indicate the passage of the interval of time during which parking is permissible and which also displays an appropriate signal when such interval of time has elagsed; and brief instructions as to its operations.

15.04.090 Parts. "Parts" means all components of a vehicle that as assembled do not constitute a complete vehicle.

15.04.100 Physically handicapped person. "Physically handicapped person" means a person who has been issued a special registration plate for a motor vehicle by the Bureau of Motor Vehicles under IC 9-7-4.1-1 which limits eligibility for the plate to one who has permanently lost the use of at least one arm or one leg, or is so severely disabled as to be unable to move without the aid of crutches or a wheelchair.

 $\frac{15.04.110}{\text{public property}}$. "Private property" means all property other

15.04.120 Public property. "Public property" means a public right-of-way, street, highway, alley or park owned or operated by a governmental unit.

15.04.130 Soliciting. "Soliciting" means any one or more of the following activities:

(1) seeking to obtain gifts or contributions for the support or benefit of any charitable or nonprofit association, organization, corporation, or project;

(2) seeking to obtain contribution, support, votes or political support for any candidate;

(3) seeking to sell or obtain orders or subscriptions of goods, wares, merchandise, foodstuffs, publications, or services; or

(4) seeking to distribute any advertising, literature, or other materials.

 $\underline{15.04.140}$ Truck route. "Truck route" means a way over certain streets along which trucks coming into and going out of the city must operate.

CHAPTER 15.08

ADMINISTRATION

15.08.010 Traffic engineer. (a) The city engineer shall serve as city traffic engineer in addition to his other functions, and shall exercise the powers and duties with respect to traffic as provided in this chapter.

- (b) It shall be the duty of the traffic engineer or designee to determine the installation, proper timing, and maintenance of traffic control devices; to conduct engineering analyses of traffic accidents and to devise remedial measures; to conduct engineering investigations of traffic conditions, including those studies required by law for adoption of additional traffic regulations with respect to streets and highways under city jurisdiction; to cooperate with other city officials in the development of ways and means to improve traffic conditions; to test traffic control devices under actual conditions of traffic; and to carry out any additional powers and duties imposed by this chapter or other ordinances of the city.
- (c) The traffic engineer is authorized to designate and maintain appropriate devices, marks or lines upon the surface of the roadway and crosswalks at intersections and at such other places where there is particular danger to pedestrians, and to mark lanes for traffic on streets at such places as deemed necessary, consistent with this title.
- 15.08.020 Authority to install traffic control devices. The traffic engineer shall designate and maintain official traffic control devices when and as required by this title to effectuate city traffic ordinances, and may place and maintain such additional official traffic control devices as deemed necessary to regulate, warn, or guide traffic under city or state traffic laws.
- 15.08.030 Traffic control devices. All traffic control signs, signals and devices erected under this title shall conform to the <u>Indiana Manual on Uniform Traffic Control Devices for Streets and Highways</u> as approved by the Indiana Department of Highways. All signs and signals shall as far as practicable be uniform as to type and location throughout the city.

15.08.040 Temporary, experimental or emergency traffic regulations. The chief of police with the approval of the city traffic engineer is empowered to make regulations necessary to effectuate the provisions of this title and any other city traffic ordinances, and to make and enforce temporary or experimental regulations. Either the chief of police or the traffic engineer is empowered to

make regulations necessary to deal with emergencies or special conditions.

- (a) Temporary, experimental, or emergency regulations shall not remain in effect for more than ninety days;
- (b) In the event the chief of police, city traffic engineer or Traffic Commission recommends that any order entered under this section be made permanent, such recommendation shall be made in writing and submitted to the Common Council for its consideration within sixty days of the date of entry of said order.
- 5.08.050 Accident report fees. The police department is authorized to charge a fee of three dollars for copies of accident reports not exceeding six pages and a fee of fifty cents per page for copies exceeding six pages.

STOP, YIELD AND SIGNALIZED INTERSECTIONS

- 15.12.010 Stop intersections. (a) The intersections described in Schedule A, attached hereto and made a part hereof, are designated stop intersections. When appropriate signs are erected at the entrances to such intersections, the operator of a vehicle approaching any of the streets where a sign has been erected shall bring such vehicle to a full and complete stop before entering the intersection, except when directed by an officer to do otherwise.
- (b) The intersections described in Schedule B, attached hereto and made a part hereof, are designated multi-stop intersections, which may be a four-way stop, a three-way stop or an all-way stop. When appropriate signs are erected at the entrance to such intersections, the operator of a vehicle entering any of the streets shall bring such vehicle to a full and complete stop before entering the intersection, except when directed by an officer to do otherwise.
- 15.12.020 Yield intersections. The intersections described in Schedule C, attached hereto and made a part hereof, are designated yield intersections. When appropriate signs are erected at the entrance to such intersections, the operator of a vehicle approaching any of the streets where a sign has been erected shall slow cown and yield the right-of-way to any vehicle on the cross street, except when cirected by an officer to do otherwise.
- 15.12.030 Signalized intersections. The intersections described in Schedule D, attached hereto and made a part hereof, are designated signalized intersections. When appropriate traffic control signals are installed at each intersection, the operator of a vehicle entering the intersections shall obey the signal displayed as the driver approaches the intersection, except when directed by an officer to do otherwise.

15.24.050 Violation and Penalty

15.24.010 State speed laws applicable. The Indiana motor vehicle laws regulating the speed of vehicles shall be applicable upon the streets within this city, except as this chapter provides otherwise. Speed limits established in this chapter shall be based upon an engineering and traffic investigation as required by I.C. 9-4-1-58. When appropriate signs are erected that these speed limits are the maximum speeds that a vehicle may be driven, no person shall drive a vehicle at a speed greater than that posted.

15.24.020 Increased or decreased state speed limits. It has been determined upon the basis of an engineering and traffic investigation that the speed permitted by state law upon the streets or parts of streets described in Schedule I, attached hereto and made a part hereof, is greater or less, as specified in the schedule, than is reasonable and safe under the conditions found to exist on such streets. When appropriate signs are erected that these speed limits are the maximum speeds that a vehicle may be driven, no person shall drive a vehicle at a speed greater than that posted.

15.24.030 School speed zones. It is hereby determined that school speed zones be established on the streets or parts of streets described in Schedule J, attached hereto and made a part hereof, because of the existence of special hazards at such locations. When appropriate signs are erected, no person shall drive a vehicle at a speed greater than that posted, except that the time of such reduced speed limits shall be confined to periods when children are present. The traffic engineer shall notify the State Highway Commission in the event that school zones are located on state highways.

15.24.040 Park and playground speed zones. It is hereby determined that parl and playground speed zones shall be established on the streets or parts of streets described in ScheduleJ, attached hereto and made a part hereof because of the existence of special hazards at such locations. When appropriate signs are erected, no person shall drive a vehicle at a speed greater than 20 miles per hour, except that the time of such reduced speed limits shall be confined to periods when children are present.

15.24.050 Violation and penalty. Any violation of this chapter is a Class A Traffic Violation and subject to the penalties listed in Section 15.64(a). Such fines cannot be waived or suspended.

CHAPTER 15.28 TRUCK ROUTES

Sections:

15.28.010 Applicability 15.28.020 Restrictions 15.28.030 Truck traffic in city 15.28.040 Enforcement 15.28.050 Violation and Penalty

15.28.010 Applicability. For purposes of this chapter, "truck" shall mean any vehicle designed or operated for the transportation of property whose body weight or combined body and load weight exceeds five tons.

15.28.020 Restrictions. (a) All trucks within the city shall be operated only on the truck routes listed in Schedule K, attached hereto and made a part hereof, when appropriate signs are erected along the routes.

- (b) The restriction in subsection (a) shall not prohibit the operation of:
 - trucks upon any street where necessary to conduct business at a destination point, provided streets upon which such traffic is permitted are used until reaching the intersection nearest the destination point;

(2) emergency vehicles upon any street in the city;

(3) trucks owned or operated by the city, public utilities, or any contractor or material man, while engaged in the repair, maintenance, or construction of streets, street improvements, or street utilities within the city;

(4) trucks upon any officially established detour where such trucks could lawfully be operated upon the street for which the detour is established;

(5) local service vehicles owned or operated by the city of Bloomington or Indiana University including, but not limited to, passenger buses, garbage trucks and food service vehicles.

15.28.030 Truck traffic in the city. (a) Trucks originating from outside the city shall be subject to the following:

- (1) One Inside Destination Point. All trucks entering the city for a destination point in the city shall proceed only over truck routes and shall deviate only at the intersection with the street, upon which such traffic is permitted, nearest to the destination point. Upon leaving the destination point, such truck shall return to the truck route by the shortest permissible route.
- (2) Multiple Inside Destination Points. All trucks entering the city for multiple destination points shall proceed only over truck routes and shall deviate only at the intersection with the street, upon which such traffic is permitted, nearest to the first destination point. Upon leaving the first destination point, a ceviating truck shall proceed to other destination points by the shortest direction and only over streets upon which such traffic is permitted. Upon leaving the last destination point, a deviating truck shall return to the truck route by the shortest permissible route.
- (b) Trucks originating from inside the city shall be subject to the following:
- (1) Outside Destination Point. All trucks on a trip originating in the city, and traveling in the city for a destination point outside the city, shall proceed by the shortest direction over streets on which such traffic is permitted, to a truck route.
- (2) Inside Destination Points. All trucks on a trip originating in the city, and traveling in the city for destination points in the city, shall proceed only over streets upon which such traffic is permitted.
- 15.28.040 Enforcement. (a) The city clerk shall keep and maintain accurate maps setting out truck routes and streets upon which truck traffic is permitted. The maps shall be kept on file in the office of the city clerk and shall be available to the public.
- (t) The traffic engineer shall cause all truck routes and those streets upon which truck traffic is prohibited to be clearly posted to give notice of the provisions of this chapter.
- (c) No person shall be charged with violating the provisions of this chapter by reason of operating a truck upon a street where truck travel is prohibited unless appropriate signs are posted on the truck routes.
- (d) A police officer shall have the authority to require any person operating a truck on a street on which truck traffic is prohibited to proceed to any public or private scale to determine whether this chapter has been violated.

15.28.050 Penalty. Any violation of this Chapter is a Class B traffic violation and subject to the penalty listed in Section 15.64 (b). Each day that a violation continues shall constitute a separate offense.

15.32.010 Yellow-painted curb. A visible yellow-painted curb shall constitute notice that parking is prohibited adjacent to such curb.

15.32.020 Alley parking. No person shall park any vehicle in an alley for a period exceeding thirty minutes while loading or unloading trucks and five minutes while loading or unloading passenger vehicles.

15.32.030 Angle parking. Vehicles shall be parked only at an angle to the curb on those streets or parts of streets described in Schedule L, attached hereto and made a part hereof, when appropriate notice is provided.

15.32.040 Parking for certain purposes prohibited. No person shall park a vehicle upon any roadway for the principal purpose of displaying such vehicle for sale or washing, greasing or repairing such vehicle, except repairs necessitated by an emergency.

15.32.050 Parking during snow removal, street repair and street cleaning. All on-street parking shall be prohibited between the hours of 3:30 A.M. and 6:30 A.M. in the downtown area bounded by Seventh Street on the North, Morton Street on the West, Second Street on the South and Washington Street on the East

- (b) In the event weather conditions or the condition of city streets makes it necessary for parking on city streets to be prohibited or restricted for snow plowing, snow removal, street repair, street cleaning, and other related purposes, the coordinator of public works shall implement a parking prohibition on parts or all of streets in the city as deemed necessary. It shall be unlawful to park or allow to remain parked any vehicle on any street to which the prohibition applies during the hours of the prohibition when signs have been properly posted.
- (c) The parking prohibition shall not go into effect until twelve hours after signs have been posted stating the hours in which the prohibition will be in effect. Such signs shall be posted at regular intervals along the streets on which parking will be prohibited so that they are clearly visible along the street. The parking prohibition shall terminate at the time stated on the signs or upon their removal by authorized persons if no time is specified.
- (d) Officers of the Bloomington police department are authorized to remove or have removed any vehicle that is parked in violation of this section in accordance with the provisions of Chapter 15.48 of this code.
- (e) Violation and Penalty. Any violation of the provisions of this section is a Class C Traffic Violation and subject to the penalty listed in Section 15.64(c). Each day a violation continues shall constitute a separate offense.
- 15.32 .060 Parking of equipment or machinery. (a) No equipment or machinery, whether self-propelled or towed, shall be parked or permitted to stand on a street without a permit from the police department.
- (b) The chief of police may issue permits to persons who can show a reasonable necessity for parking temporarily on a street while engaged in construction, but such permit shall be for a limited period of time at a specifically designated site.

- (c) Service trucks may be parked on the streets while the operators are engaged in the repair or service of utilities if no suitable off-street parking is evailable.
- (d) Violation and Penalty. Any violation of this section is a Class C vio ation and subject to the penalty listed in Section 15.64(c).
- 15.32.070 Certain vehicles Two hour limit. No person shall allow a truck, trailer, tractor, bus, housetrailer, semi-trailer, or other vehicle having a load capacity in excess of one ton, or a length in excess of nineteen feet, or a height in excess of six feet six inches, or a width in excess of seven feet to be parked upon the streets of the city in excess of two hours. This prohibition shall not apply to pick-up type campers. Any violation of this section is a Class C Violation and subject to the penalty listed in Section 15.64(c).
- 15.32.080 No parking zones. The streets or parts of streets described in Schedule M, attached hereto and made a part hereof, are designated as no parking zones. When appropriate signs are erected no person shall park a vehicle upon any of the streets or parts of streets at the times designated in the schedule.
- 15.32.090 Limited parking zones. The streets or parts of streets described in Schedule N, attached hereto and made a part hereof, are designated limited parking zones. When appropriate signs are erected no person shall park a vehicle upon any of the streets or parts of streets for a period of time longer than the maximum limit designated in the schedule.
- 15.32.100 Loading zones. (a) Loading zones shall be in effect twenty-four hours a day seven days a week. Trucks and passenger vehicles may use the loading zones without charge. Passenger vehicles shall be limited to a maximum of five minutes use to load and unload passengers and trucks shall be limited to a maximum of thirty minutes use to deliver and pick up materials.
- (b) In addition to the loading zones described in Schedule 0, attached herato and made a part hereof, all alleys may be used as loading zones subject to the limitations in subsection (a), but it shall not be necessary to erect signs to this effect.
- 15.32.110 Bus zones. The streets or parts of streets described in Schedule P, attached hereto and made a part hereof, are designated as bus zones. When appropriate signs are erected no person shall stop, stand or park a vehicle other than a bus in a bus zone.
- 15.32.120 Official vehicles zones. The streets or parts of streets described in Schedule R, attached hereto and made a part hereof, are designated as official vehicle zones. When appropriate signs are erected no person shall stop, stand or park a vehicle other than an official vehicle in an official vehicle zore.
- 15.32.130 Parking near intersections. No vehicle shall park within twenty feet of any other street intersection other than any state highway intersection.
- 15.32.140 Obstructing traffic. No person shall park any vehicle upon a street, other than an alley, in such a manner or under such conditions as to leave available less than ten feet of the width of the roadway for free movement of vehicular traffic.
- 15.32.150 Handicapped parking spaces. (a) A number of parking spaces on public streets shall be reserved for use by physically handicapped persons. Parking time limits, fees and other regulations in this title generally in effect for spaces in adjacent areas shall apply as well to those spaces for parking by handicapped persons.
- (b) Signs posted to indicate the reserved spaces shall bear the official international wheelchair symbol and state that use of the space by an ineligible vehicle is a Class C infraction of the state criminal code punishable by a fine of up to five hundred dollars.
- (c) The parking spaces described in Schedule S, attached hereto and made a part hereof, are designated as parking spaces reserved for handicapped persons.
- (d) It shall be unlawful to park a vehicle without a special registration plate for a handicapped person in a handicapped parking space. Tickets issued for violations of this section shall be referred to the Monroe County Prosecutor for enforcement as a Class C infraction.

- 15.32.160 Emergency vehicle lanes. (a) It is unlawful to cause or permit any vehicle or other obstacle to park or remain in any lane, alley, privately owned public parking lot, driveway, or service area, within sixteen feet of any building, accessory structure or sidewalk which is immediately adjacent to or attached to any building, where such building is occupied for commercial, professional, religious, or other type of occupancy or assembly, in such a manner as would obstruct the free passage of fire department vehicles, police cars, emergency or rescue vehicles, or any other vehicles performing a public or emergency function, except for such time as is necessary for the loading or unloading of passengers or merchandise. Where there are areas inaccessible to vehicular traffic between a lane, alley, privately owned public parking lot, driveway, or service area and any building, accessory structure or sidewalk immediately adjacent to or attached to any building, the restricted area of sixteen feet shall be measured from the inaccessible areas abutting the lane, alley, privately owned public parking lot, driveway, or service area and a sixteen-foot emergency vehicle lane established so as to permit free and continuous passage of emergency vehicles.
- (b) The city fire department shall inspect the area surrounding all buildings to which this section applies, and the fire chief with the approval of the traffic engineer shall determine the location of emergency vehicle lanes and shall notify the affected property owners in writing, together with a notation as to the number of signs deemed necessary by the fire department to properly notify drivers of the existence and location of emergency vehicle lanes. Where it is the opinion of the fire chief that compliance with this subsection would not serve to further the purposes intended by this section, he shall advise the affected property owners or managers in writing that such compliance, in part or full, is waived. The erection and maintenance of signs shall be the responsibility of each property owner.
- (c) It shall be the joint duty of the officers of the police and fire department to enforce the provisions of this section. To aid in enforcement, the fire chief shall obtain from each property owner, lessee or person in possession of property subject to this section an affidavit granting permission and consent to the towing away of any personal property which is obstructing emergency vehicle lanes. The original affidavits shall be kept on file in the city attorney's office with duplicates filed in the fire chief's office.
- (d) Any person who fails to erect or maintain an emergency vehicle sign as directed by the fire department commits a Class B violation and is subject to the penalty listed in Section 15.64(b).
- (e) Any person who fails or permits a vehicle or obstacle to remain in an emergency vehicle lane in violation of subsection (a) commits a Class C Traffic Violation and is subject to the penalty listed in Section 15.64(c) and the enforced removal of the vehicle or obstacle in violation. Each day that a violation continues shall constitute a separate offense.
- 15.32.170 Violation and Penalty. Any person who violates any provision of this chapter for which a specific penalty has not been provided, commits a Class D Traffic Violation and is subject to the penalties listed in Section 15.64(d).

15.36.010 Eligibility. (a) Any person residing in a single household detached dwelling in an area of the city zoned for residential purposes who owns an automobile may apply to the city controller for a permit for one parking space adjacent to such residential property. At the time of application, a valid automobile registration shall be shown.

- (b) "Adjacent" means abutting the property of the residence or, if no such space is available, then directly across the street and within the same block as the residence.
- (c) "Household" means a single individual living upon the premises as a single housekeeping unit or a collective body of persons living upon the premises as a single housekeeping unit.
- (d) "Single household detached dwelling" means a building designed for the occupancy of no more than five adults, i.e., persons sixteen years of age or older and any dependent children of the household. Such dwellings shall be characterized by, but not limited to:
 - (1) A single house number with a single mailbox for the receipt of materials sent through the United States mail;

(2) A single kitchen adequate for the preparation of meals;

(3) A tenancy based upon a legal relationship of a unitary nature, i.e., single lease, mortgage or contractual sales agreement for the entire premises.

15.36.020 Information required in application. The application form shall contain the name and address of the applicant; the year, make, and license number of the automobile owned by the applicant which is authorized to use the private parking space; and a signed statement from the applicant that he resides at the address given in the application, that he owns the listed automobile, and that he does not have adequate off-street parking as defined in this chapter. Should the automobile and/or its license number change while a permit is in force, the applicant shall amend the application.

15.36.030 Information contained on permit. The permit provided for in this chapter shall contain the following information: number of the permit; name and address of the person to whom the permit is issued; year, make, and license number of vehicle authorized to use space; and month and date of issuance and date of expiration.

15.36.040 Decal required. A small, self-adhesive, colored decal bearing the expiration date of the permit will be issued and the decal shall be affixed to the sign at the location of the private residential parking space. The color of the decal shall change each year. The absence of the decal shall be presumptive evidence that the permit has expired.

- 15.36.050 Expiration of permits. All permits expire on December 31 of the year of issuance. Permits previously issued must be renewed by February 15 or the application and permit expire.
- 15.36.060 Fees. An initial administrative fee of twenty-five dollars and an annual permit fee of twenty-six dollars shall be paid upon issuance of a permit. An annual permit fee of twenty-six dollars shall be paid thereafter (thirteen dollars after July 1).
- 15.36.070 Issuance and revocation of permits. (a) The application for a permit under the provisions of this chapter shall be submitted to the city controller who shall forward it to the traffic engineer. The traffic engineer shall approve or disapprove the application in accordance with the provisions of this chapter. An adverse ruling may be appealed to the Board of Public Works, whose decision shall be final.
- (b) The Board of Public Works shall have the authority to revoke any permit upon finding violation of the regulations in this chapter and to order the forfeiture of all fees paid.

15.36.080 Regulations for permit holders. The following regulations shall be in effect:

(1) A permit shall be issued only when there is a lack of adequate off-street parking at applicant's place of residence. "Adequate off-street parking" shall be defined as space for one automobile, including adequate access to that space.

(2) Permits shall be restricted to one per residence.

(3) Permits shall be valid only for the calendar year in which they are issued.

(4) Private parking spaces shall be used for passenger vehicles only.

(5) Private parking spaces shall not be subleased or rented, for consideration or gratuitously, to individuals outside the applicants household.(6) A permit shall not be issued for any space in which there is a parking

(6) A permit shall not be issued for any space in which there is a parking meter installed by the city.

(7) The permit holder will purchase and maintain a standard sign as designated by the city.

15.36.090 Disposition of revenue. All funds derived from the granting of permits under the provisions of this chapter shall be placed in the general fund of the city.

15.36.100 Violation and Penalty. Any violations of this chapter constitute a Class D Traffic Violation and are subject to the fines listed in Section 15.64 (d) as well as enforced removal of the vehicle.

 (6) Lot 6: located at the 200 block of East Third Street on part of fractional out-lot 20, and containing not less than twelve parking meters
- (7) Lot 8: located at the northeast corner of West Kirkwood and Morton Street on part of in-lot 157.
- (8) Municipal parking garage: located at the northwest corner off the square bounded on the east by College Avenue, on the north by Seventh Street, on the west by Morton Street and on the south by Sixth Street on in-lots 265 and 266 of the city.

- 15.40.020 Applicable times and charges. (a) The charge for the use of all municipal parking lots and the municipal parking garage shall be five cents per thirty-minute period or part thereof and ten cents per sixty minutes for the use of each space between the hours of nine a.m. and five p.m. every day except Saturdays, Sundays and public holidays. The charge shall be collected by parking meters.
- (b) No vehicle shall park in a metered space in Lot 6 for more than one hour in any day when parking meters are in operation.
- 15.40.030 Annual parking permits. (a) The city will issue two types of annual parking permits. A limited number of annual parking leases, hereafter referred to as Class A permits (not to exceed 25% of the available spaces) for specific spaces on the lower level of the Municipal Parking Garage are available. The charge for such spaces shall be two hundred dollars per year. Only motor vehicles displaying a Class A permit for that stall may park in a leased stall. Any car illegally parked in a leased stall shall be both ticketed and immediately towed.
- (b) Annual parking privileges, hereafter referred to as Class B permits, shall be made available for parking on a rental basis in any of the city parking lots and in available spaces excluding those designated for Class A permits in the municipal parking garage. The charge for such privilege shall be one hundred and forty dollars per year, payable in advance.
- (c) The city shall furnish for each motor vehicle upon the application for such parking privilege and upon payment a permit indicating the class of permit and the payment therefor.
- (d) It shall be the duty of the city controller to issue permits, collect and account for the rents received, and deposit such moneys to the credit of the city in a special fund provided by law for parking meter receipts. However, receipts collected from permits and parking meters of the municipal parking garage are to be deposited in accordance with the Interdepartmental Agreement between the Redevelopment Commission and the Board of Public Works for the operation of the facility.
- 15.40.040 Parking lots leased by city. Every parking lot leased by and under the control of the city and upon which meters have been properly placed and calibrated shall be subject to the provisions of this chapter in the same manner as if such lot were owned outright by the city.
- 15.40.050 Violations. (a) No person shall permit a vehicle to remain in a metered parking space after the time limit shown upon the meter for such space has elapsed or after any restriction on the length of time a vehicle may park in a particular parking lot has elapsed.
- (b) No person shall park in a leased stall in the municipal parking garage without a Class A permit sticker displayed in the lower right corner of the windshield of the vehicle.
- (c) No person shall permit a vehicle to remain parked in a backed position in a parking space in any municipal parking lot.
- (d) No person shall deface, injure, tamper with, open or willfully break, destroy or impair the usefulness of any parking meter installed under the provisions of this chapter.
- (e) No person shall deposit or cause to be deposited in any parking meter any slug, device or metallic substance or any other substitute for any coin of the United States.
- 15.40.060 Violation and Penalty. Any violation of this chapter is a Class D Traffic Violation and subject to the penalty listed in 15.64 (d).

15.44.010 Established. There is established a traffic commission consisting of eleven members who shall serve without compensation.

15.44.020 Membership--Removal of members. (a) The commission shall be made up of the following ex-officio members: a designee of the city engineer, a designee of the city street superintendent, and a designee of the chief of police. In addition, there shall be eight members, six of whom shall be district representatives and two of whom shall be representatives of the city at large, all of whom shall be appointed to a term of two years. The six districts shall correspond with the current councilmanic districts and each district representative shall be a resident of the district from which he is appointed. All members of the commission shall be voting members.

(b) The six district members shall be appointed by the common council and the two at-large members shall be appointed by the mayor. If a member dies or leaves the commission for any reason, a successor shall be appointed by the appropriate body or official to serve for the unexpired term for which the member is

term for which the member was appointed.

(c) Commission members may be removed for cause. "Cause" shall include, but not be limited to, failure to attend three consecutive regularly scheduled meetings of the commission in any twelve-month period; provided, that any commission member may submit in writing to the mayor if the mayor appointed him, or the common council if the council appointed him, any extenuating circumstances. Such written submission must be made before the formal decision to remove is reached. Acceptance of extenuating factors by the appointing body or official puts the commission member on notice that further excessive absenteeism will result in removal.

15.44.030 Meetings. Commission meetings will be held on a monthly basis at a regular time as designated by the commission's rules of procedure. Special meetings may be called by the chairperson upon giving two day's notice thereof.

15.44.040 Rules of procedure. The commission shall establis own rules of procedure which may be amended from time to time by a The commission shall establish its majority of the membership.

It shall be the duty of the commission, and to 15.44.050 Duties. this end it shall have the authority within the limits of the funds at its disposal, to coordinate traffic activities, to carry on educational activities in traffic matters, to supervise the preparation and publication of traffic reports, to receive complaints having to do with traffic matters, and to recommend to the common council and to appropriate city officials ways and means for improving traffic conditions and the administration and enforcement of traffic regulations.

15.48.010 General Provisions. (a) Vehicles parked in any of the following circumstances are declared public nuisances and shall be subject to the emergency removal and impoundment procedures authorized by this chapter, as well as any fines set by state law or city ordinance:

(1) Any vehicle which constitutes an impediment to the free flow of traffic in the area in which the vehicle is found;

(2) Any vehicle parked in a fire lane in violation of section 15.32.160 of this code:

(3) Any vehicle upon which there is a police department hold;

(4) Any vehicle whose operator is unable to move such vehicle due to the person's arrest or other incapacity;

Any vehicle parked in a duly authorized residential parking permit area without permission of the permit holder after complaint to the Bloom-

without permission of the permit holder after complaint to the Bloomington police department, in violation of chapter 15.36 of this code; (6) Any vehicle parked in an annual leased stall in the municipal parking

(6) Any vehicle parked in an annual leased stall in the municipal parking garage without displaying a Class A permit for that stall in violation of section 15.40.030 of this code;

(7) Any vehicle parked in violation of the snow removal, street repair and street cleaning provisions of section 15.32.050 of this code;

(8) Any vehicle which has accumulated five or more unpaid parking tickets in the city within any consecutive twelve-month period, for which parking violation notices were issued but which have not been paid, presented for compromise payment, or slated into a court of competent jurisdiction;

(9) Any vehicle required to be registered under IC 9-1-4 which does not have the proper registration or license plates attached, in violation of IC

9-9-5-5;

- (10) Any vehicle discovered by a police officer in possession of a person other than the owner and the person cannot establish right to possession of that vehicle, as specified in IC 9-9-1.1-4 and section 15.52.030 of this code.
- (b) When any vehicle is parked in any of the circumstances enumerated in subsection (a) of this section, such fact shall be prima facie evidence that the owner is chargeable for the violation.
- 15.48.020 Emergency removal and impoundment procedure. (a) Any officer of the Bloomington police department discovering a public nuisance as described in section 15.48.010 shall cause the vehicle to be removed by an authorized towing service. If the owner or operator appears at the site of the violation before the vehicle is removed and executes a written promise to appear in court, then the vehicle shall be released.
- (b) Impounded vehicles shall be released without payment of the towing and storage charges upon order of the Bloomington police department or the judge of a court of competent jurisdiction, or upon the owner's executing a written promise to appear in court.
- 15.48.030 Towing and storage charges. (a) The maximum amount that an authorized towing service may charge for towing or removing a vehicle under this chapter shall not exceed twenty-five dollars except where special equipment may be required. The maximum amount that may be charged for storage shall not exceed five dollars per day.
- (b) Towing and storage charges shall be the responsibility of the owner and shall be payable directly to the authorized towing service.
- 15.48.040 Disposal of impounded vehicles. Impounded vehicles shall be disposed of in accordance with the provisions of Chapter 15.52 of this code and IC 9-9-1.1.

15.48.050 Liability for loss or damage. Neither the owner, lessee, or occupant of the property from which a vehicle is removed, nor the police department or authorized towing service is liable for loss or damage to the vehicle during its removal or storage.

15.48.060 Payment of fines. The owner of the impounded vehicle shall be responsible for paying any applicable fine.

CHAPTER 15.52 ABANDONED VEHICLES

15.52.010 Applicability. (a) This chapter shall apply to vehicles in possession of persons other than owners of the vehicles and to abandoned vehicles as defined in Chapter 15.04.

- (b) This chapter shall not apply to any vehicle:
- (1) In operable condition specifically adapted or constructed for operation on privately owned raceways;

(2) Stored as the property of a member of the armed forces of the United States who is on active duty assignment;

(3) Located on a rehicle sale lot or at a commercial vehicle servicing facility:

(4) Located upon property licensed or zoned as an automobile scrapyard; or

(5) Registered and licensed under IC 9-7-6 as an antique vehicle.

15.52.020 Responsibility of owner. The owner of an abandoned vehicle is responsible for the abandonment and is liable, to the extent of the market value of the vehicle, for all of the costs incidental to the removal, storage, and disposal of the vehicle or its parts.

- 15.52.030 Vehicles in possession of person other than owner. (a) When an officer discovers a vehicle in the possession of a person other than the owner and the person cannot establish his right to the possession of that vehicle, the vehicle shall be taken to and stored in a suitable place. The bureau shall be notified within seventy-two hours of the location and description of the vehicle. Upon receipt of notification the bureau shall cause a search to be made to determine and notify the owner.
- (b) If the owner of the vehicle cannot be determined, the bureau shall declare the vehicle abandoned and provide for its disposal in accordance with this chapter.
- (c) If the properly identified owner or lienholder appears at the site of storage before disposal of the vehicle or parts and pays all proper costs incurred against it at that time, then the vehicle or parts shall be released. A copy of the release of all vehicles or parts shall be sent to the bureau. The release must contain the owner or lienholder's signature, name, address, vehicle or parts description, costs, and date of release.
- (d) If the vehicle is not released to the owner or lienholder, the bureau shall declare the vehicle abandoned and provide for disposal in accordance with this chapter.
- 15.52.040 Removal of abandoned vehicles. (a) An officer who finds a vehicle or parts believed to be abandoned shall attach in a prominent place a notice tag containing the following information:

(1) The date, time, officer's name, city police department, and address and telephone number to contact for information.

2) That the vehicle or parts are considered abandoned.

- (3) That the vehicle or parts will be removed after seventy-two hours.
- (4) That the owner will be held responsible for all costs incidental to the removal, storage, and disposal, and if not paid the owner's registration privileges will be suspended on that car.
- (5) That the owner may avoid costs by removal of the vehicle or parts within seventy-two hours.
- (b) If the tagged vehicle or parts are not removed within the seventy-two hour period, the officer shall prepare a written abandoned vehicle report of the vehicle or parts including information on the condition, missing parts, and other facts that might substantiate that the market value is less than one hundred dollars. Photographs shall be taken to describe the condition of the vehicle or parts.
- (c) If, in the opinion of the officer, the market value of the abandoned vehicle or parts is less than one hundred dollars, the officer shall immediately dispose of the vehicle to an automobile scrapyard. A copy of the abandoned vehicle report and photographs relating to the abandoned vehicle shall be forwarded to the bureau. The Police Department shall retain the original records and photographs for at least two years.
- (d) If, in the opinion of the officer, the market value of the abandoned vehicle or parts is one hundred dollars or more, the officer, before placing a notice tag on the vehicle or parts, shall make a reasonable effort to ascertain the owner or person who may be in control of the vehicle or parts. After seventy-two hours, the officer shall require the vehicle or parts to be towed to a storage area.
- 15.52.050 Disposal of abandoned vehicles. (a) Within seventy-two hours after removal of an abandoned vehicle to a storage area under this chapter, the police department shall prepare and forward to the bureau an abandoned vehicle report containing a description of the vehicle including the make, model, engine number, if any, identification number, and the number of the license plate, and request that the bureau advise the police department of the name and most recent mailing address of the owner and any lienholder.
 - (b) The bureau shall dispose of the vehicle in accordance with IC 9-9-1.1.
- 15.52.060 Maximum towing and storage charges. The maximum amount that an authorized towing service may charge for towing or removing a vehicle under this chapter shall not exceed twenty-five dollars except where special equipment is required. The maximum amount that may be charged for storage shall not exceed five dollars per day.
- 15.52.070 Towing contracts. To facilitate the removal of abandoned vehicles or parts or vehicles declared public nuisances, the police department may enter into towing contracts or agreements for the removal and storage of abandoned vehicles and parts.
- 15.52.080 Liability for loss or damage. Neither the owner, lessee, or occupant of the property from which an abandoned vehicle or parts are removed nor the police department, authorized towing service, or automobile scrapyard is liable for loss or damage to the vehicle or parts occurring during its removal, storage, or disposition.

- 15.56.010 Applicability of state laws. Every person who operates a bicycle upon any street or road shall be subject to the state laws concerning bicycles as se; out in IC 9-4-1 and to all city traffic ordinances except where additional requirements are imposed by this chapter, or the nature of such rules or ordinances renders them inapplicable to bicycles or bicycle traffic.
- 5.56.020 Riding on Sidewalks. No person shall operate a two-wheeled bicycle on a sidewalk if the wheel radius of the bicycle exceeds fourteen (14) inches. All persons riding bicycles on sidewalks permitted by this section shall yield to pedestrians.
- 15.56.030 Bicycle license required. (a) No person shall ride a bicycle on any read, street, or bicycle path within the city unless the bicycle has been licensed and a valid license decal firmly attached to the seat tube of such bicycles. Bicycles owned by non-residents of Bloomington and bicycles validly registered by Indiana University, Bloomington, are exempt from this license requirement.
- 15.56.040 Issuance of license. The city controller chall, upon receiving proper application, issue a bicycle license decal, at no charge to the applicant.
- 15.56.050 Bicycle license records. (a) The city controller shall maintain a record of all bicycle licenses issued. Such record shall contain the number of the license decal issued, the date of issue, the name and address of the owner, the make and serial number of the bicycle, and any other information deemed necessary.
- (b) A duplicate of the record provided for in subsection (a) of this section shall be maintained by the city police department.
- : 15.56.060 Removal of license decal prohibited. No person shall remove a license decal from a bicycle during the period for which the license was issued except upon a transfer of ownership of the bicycle, or in the event the bicycle is dismantled and is no longer operated upon any street, road or bicycle path in the city.
- 15.56.070 Bicycle rentals. (a) Any person or business who rents or offers a bicycle for rent in this city shall be responsible for compliance with all license and safety equipment requirements and shall indemnify any person renting such bicycle for fines incurred due to any non-compliance with these requirements.
- (b) Failure to license rental bicycles and to indemnify renter for any fines incurred is a Class B Traffic Violation subject to the penalty listed in Section 15.64 (b).
- 15.56.080 Bicycle paths established. Bicycle paths are established for the purpose of providing a separate traffic lane on designated city streets for the sole use of persons riding bicycles. Bicycle paths shall be located on a strip four feet wide and shall be separated from the automobile traffic lane by solid lane-marking strips. The location of bicycle paths shall be designated by signs and/or appropriate markings on the surface of the street. The following are designated bicycle paths:
 - (1) East side bicycle path: the path that runs parallel to and south of the Illinois Central and Gulf Railroad tracks between the State Road 46 bypass and the Park Ridge subdivision.
 - (2) Tenth Street bicycle path: the path that runs parallel to and north of Tenth Street between the University Elementary and Middle Schools and the extension of Pete Ellis Drive.
 - (3) Path running between Nota Drive and Maxwell Lane.
 - (4) Path running between Maxwell Lane and Binford Middle School.
 - (5) Path running between Wexley Road and Winslow Sports Complex.
- 15.56.090 Right-of-way of bicycle riders. (a) Any bicycle rider legally within a bicycle path shall have the right-of-way.
- (b) The use of motorized vehicles on bicycle paths is prohibited; provided, however, that motorized bicycles of less than fifty cubic centimeters (cc) engine displacement shall not be considered motorized vehicles for purposes of this section.

- (c) Rules and regulations applying to pedestrians, bicycles, and motorized bicycles of less than 50 cc engine displacement shall apply on bicycle paths.
- 15.56.100 Violation and penalty. Violation of any provision of this chapter other than Section 15.56.070 is a Class E Traffic violation and is subject to the penalty listed in Chapter 15.64 (e). Each day that violation continues shall constitute a separate offense.

CHAPTER 15.60

15.60.010 Soliciting in roadway. Soliciting in the roadway shall be unlawful. Violation of this section is a Class C Traffic Violation and subject to the penalty listed in Section 15.64 (c). Each day that a violation occurs shall constitute a separate offense.

15.60.020 Driving in park, picnic ground or golf course. No person shall operate a motor vehicle, motorcycle or motorized bicycle across any part of a public park, picnic ground, golf course, or other public property not designed and intended to be used by motor vehicles. Any violation of this Section is a Class C Traffic Violation and subject to the penalty listed in Section 15.64(c).

15.60.030 Prohibition of coasters, skateboards, and roller skates. No person upon roller skates, skateboards, or riding in or by means of any coaster, toy vehicle or similar device, shall go upon any roadway except while crossing a street in a crosswalk, and when so crossing such person shall be granted all the rights and shall be subject to all of the duties applicable to pedestrians. Any violation of this Section is a Class E Traffic Violation and subject to the penalty listed in Section 15.64(e).

<u>15.60.040 Driving or parking on sidewalks.</u> No person shall drive or park a vehicle within any sidewalk area except at a permanent or temporary driveway. Any driving violation under this section is a Class C Traffic Violation and subject to the penalty listed in Section 15.64(c). Any parking violation under this section is a Class D Traffic violation and subject to the penalty listed in Section 15.64(d).

15.60.050 Pedestrians. No pedestrians shall cross a roadway other than in a crosswalk. Pedestrian crossings shall be established at all intersections and at the following locations:

(1) 800 block of Atwater in front of the Optometry Building;

(2) 2000 block of South Henderson at the drive into Henderson Court;

(3) 3401 Valley View Drive.

Any violation of this section is a Class E Traffic Violation and subject to the penalty listed in Section 15.64(e).

15.60.060 Train speeds at grade crossings. It is unlawful for any person operating a railroad in or through the city to operate its trains, engines and cars at grade, over any street or highway within the city, at a speed greater than twenty-five miles per hour. Any violation of this section is a Class A Traffic Violation and subject to the penalty listed in Section 15.64(a).

SECTION II. Section 12.16 entitled "Parking permits", Section 12.23 entitled "Truck routes" and Section 18.04.120 entitled "Parking adjacent to building" of the Bloomington Municipal Code shall be repealed.

SECTION III. It is hereby determined and declared that the provisions of this Ordinance are restatements and reenactments of original Title 15 of the Bloomington Municipal Code.

SECTION IV. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this chapter are declared to be severable.

SECTION V. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor and promulgation as required by law.

SYNOPSIS

This ordinance repeals and reenacts Title 15 of the Bloomington Municipal Code to delete all regulations covered by state statute, to provide a current listing of the locations of all local traffic and parking regulations, and to consolidate within this Title sections dealing with traffic that were previously codified in Chapters 12 and 18.
