

To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, PUD-73-81, and recommended that the petitioner, D.G. Elmore, be granted an amendment to the Bloomington zoning maps and request that the Common Council consider their petition for rezoning of certain property:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 and pursuant to Chapter 20.13 of the Bloomington Municipal Code, that an outline plan be approved and the site be designated a planned unit development, for property located at Southeast Corner of Blue Ridge Dr. & S.R. 37 more particularly described as follows:
A part of the Southwest quarter of Section 21, Township 9 North, Range 1 West, Monroe County, Indiana, bounded and described as follows; Beginning at a point that is 136.90 feet North and 1118.48 feet West of the Southeast corner of the Southwest quarter in said Section 21, thence running North for 814.70 feet and to the West right-of-way of Blue Ridge Drive, thence along said Drive with a curve having a radius of 3865.00 feet for 289.60 feet, thence North 36 degrees 58 minutes 46 seconds West for 201.20 feet and to the South right-of-way of Blue Ridge Drive, thence along said Drive the following courses and distances, South 42 degrees 38 minutes 14 seconds West for 91.30 feet, thence with a curve to the right having a radius of 270.00 feet for 137.36 feet, thence South 71 degrees 47 minutes 14 seconds West for 49.30 feet and to the East right-of-way of State Road Number 37, thence leaving said Blue Ridge Drive and following said State Road right-of-way South 16 degrees 44 minutes 17 seconds East for 522.12 feet, thence South 15 degrees 51 minutes 14 seconds East for 317.26 feet, thence leaving said State Road East for 221.14 feet, thence South 14 degrees 50 minutes 25 seconds East for 250.46 feet and to the point of beginning. Containing in all 7.63 acres more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
