

ORDINANCE NO. 82-57

AN ORDINANCE CONCERNING THE ANNEXATION
OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE
CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the
same is, hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

A part of Edgemont Park Addition, Bloomington,
Indiana, described as follows: Lots 16 through
25, Lots 31 through 80, Lots 101 through 120,
Lots 126 through 135, and Lots 144 through 152
in said Edgemont Park Addition. Said lots and
adjacent streets and alleys comprising the
following described tract: Beginning at the
Northwest corner of Lot 20 in said Edgemont
Park Addition; thence East over and along the
South line of Davis Street for a distance of
1068 feet to the Northeast corner of Lot 80;
thence South over and along the West line of
Woodlawn Avenue for a distance of 1299 feet to
the Southeast corner of Lot 101; thence West
over and along the North line of Hillside Drive
for a distance of 276 feet to the Southwest
corner of Lot 120; thence North for a distance
of 297.5 feet to the Northwest corner of Lot
116; thence West for a distance of 356 feet
over and along the South line of Wilson Drive
to the Northeast corner of Lot 145; thence
South over and along the West line of Stull
Avenue for a distance of 120 feet to the South-
east corner of Lot 144; thence West for a dis-
tance of 132 feet to the Southwest corner of
Lot 144; thence South for a distance of 181
feet to the North line of Hillside Drive;
thence West over and along the North line of
Hillside Drive for a distance of 23 feet to the
Southwest corner of Lot 152; thence North for
a distance of 658 feet to the Northwest corner
of Lot 151; thence East for a distance of 32
feet to the Northwest corner of Lot 150; thence
North for a distance of 317 feet to the North-
west corner of Lot 35; thence West over and
along the South line of Grimes Street for a
distance of 304 feet; thence North for a distance
of 330 feet to the point of beginning. Containing
22.5 acres, more or less.


SECTION 2. Be it further ordained, that the boundaries of

described as part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.




