TO RATIFY THE LEASE TO THE BLOOMINGTON PUBLIC TRANSPORTATION CORPORATION OF NINETEEN MOTOR VEHICLES, THEIR CONTENTS, PARTS OF LOTS 78, 79, 80, 81, 82 AND 83 IN THE BARCLAY GARDENS ADDITION TO THE CITY OF BLOOMINGTON.

WHEREAS, the Common Council of the City of Bloomington created the Bloomington Public Transportation Corporation under Ordinance 82-41 of the Bloomington Municipal Code; and

WHEREAS, the Bloomington Public Transportation Corporation, in order to carry out its public functions of relieving City traffic congestion, providing service to and from places where members of the general public congregate, expanding the economic and social opportunities available to municipal residents, and maintaining real property values in the municipality is desirous of making use of the City's nineteen motor vehicles, their contents, parts of lots 78, 79, 80, 81, 82 and 83 in the Barclay Gardens Addition to the City of Bloomington, and improvements thereon (hereafter designated as "bus barn"); and

WHEREAS, the Common Council of the City of Bloomington is desirous of leasing said vehicles, their contents, the bus barn, and improvements thereon, the Bloomington Public Transportation Corporation;

NOW, THERFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, THAT:

SECTION I. The lease between the City of Bloomington and the Bloomington Public Transportation Corporation which is attached hereto, for said vehicles, their contents, the bus barn, and improvements thereon, is hereby ratified.

SECTION II. Severability. If any section of this ordinance or any part of any section shall be declared invalid or unconstitutional, such declaration shall not affect the validity or constitutionality of the remaining portions.

SECTION III. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
