

ORDINANCE 81-32

To Amend Section 15.64.410, entitled "No Parking Zones", 15.64.080, entitled "Parallel Parking", 15.64.100, entitled "Angle parking", and 15.76.020, entitled "Yield Intersections", of the Bloomington Municipal Code

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.64.410 of the Bloomington Municipal Code, entitled "No Parking Zones," shall be amended to add the following:

East side of North Monroe Street between the north leg of Cottage Grove Avenue and Eleventh Street.

Both sides of West Third Street between Adams Street and State Road 37.

SECTION II. Section 15.64.410 of the Bloomington Municipal Code, entitled "No Parking Zones" shall be amended to remove the following:

Both sides of the 600 block of North Monroe Street between Eleventh Street and Cottage Grove.

SECTION III. Section 15.64.080 of the Bloomington Municipal Code, entitled "Parallel Parking", shall be amended to add the following:

South side of the 100 block of West Seventh Street.

SECTION IV. Section 15.64.100 of the Bloomington Municipal Code, entitled "Angle Parking -- Streets designated", shall be amended to remove the following:

Seventh Street, south side, from College Avenue to first alley east of Walnut Street.

SECTION V. Section 15.76.020 of the Bloomington Municipal Code, entitled "Yield Intersections", shall be amended to add the following:


Christopher Drive. The traffic on Christopher Drive shall yield to the traffic on Brownridge Road.

SECTION VI. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.



SYNOPSIS

This ordinance, submitted by the Traffic Commission, would designate both sides of N. Monroe Street, between the north leg of Cottage Grove Avenue and 11th Street, and both sides of W. Third Street between Adams Street and SR 37 as No Parking Zones; would change the parking on the south side of the 100 block of W. 7th Street from angle to parallel parking; and require that traffic on Christopher Drive yield to traffic on Brownridge Road.
