To Approve an Interlocal Cooperation Agreement for Development  
and Teaching of Career Exploration and Job-Seeking Courses

WHEREAS, the City Human Resources Department has obtained funds from the State Board of Vocational and Technical Education to assist displaced homemakers; and

WHEREAS, the Human Resources Department has developed a project to assist displaced homemakers in finding jobs and the Adult Education Program of the Monroe County Community School Corporation has agreed to design materials and teach a program for the project; and

WHEREAS, IC 36-1-7-2 requires that the agreement between the Human Resources Department and the AEP be approved by each governmental unit;





SYNOPSIS

This resolution approves an agreement between the City Human Resources Department and the Adult Education Program of the Monroe County Community School Corporation in which the Adult Education Program will design materials and teach a program to assist displaced homemakers in finding jobs. The program is being funded by the State Board of Vocational and Technical Education.

INTERLOCAL COOPERATION AGREEMENT  
FOR DEVELOPMENT AND TEACHING OF  
CAREER EXPLORATION AND JOB-SEEKING  
COURSES

This agreement made and entered into by and between the Human Resources Department of the City of Bloomington, hereinafter referred to as HRD, and the Adult Education Program of the Monroe County Community School Corporation, hereinafter referred to as AEP. Under the authority of Indiana Code 36-1-7-2, witnesseth:

WHEREAS, HRD has obtained funds awarded by the State Board of Vocational and Technical Education for utilization in assistance to displaced homemakers;

WHEREAS, HRD has developed a project with the goal of assisting displaced homemakers in finding jobs with the ultimate goal of becoming economically independent;

WHEREAS, AEP has agreed to design materials and teach a program to achieve said goal;

NOW THEREFORE, HRD and AEP do hereby agree according to the following terms and conditions:

1. AEP shall develop a course titled Career Exploration, including complete lesson plans, objectives, and activities. Consideration for development shall be at an hourly rate of fourteen dollars (\$14.00) per hour, up to a maximum of eighty (80) hours, or \$1,120.00. Development shall be completed on or before January 31, 1982.
2. AEP shall teach at least one session of two courses. A second session may be taught if required by HRD. Courses shall be: (a) Career Exploration; and (b) Job-Seeking and Job Retention. Materials for the teaching of Job-Seeking and Job Retention are currently available for teaching and shall not be developed by AEP. Consideration for instruction shall be at an hourly rate of fourteen (\$14.00) dollars per hour up to a maximum of forty (40) hours for one session (\$560.00) or eighty (80) hours for two sessions, (\$1120.00). The first session shall be completed on or before March 31, 1982. A second session, if required by HRD, shall be completed on or before September 30, 1982.
3. AEP agrees to print course materials for distribution in course sessions and for distribution by HRD to other adult education programs in Indiana. Printing costs shall be compensated to AEP by HRD according to actual cost, up to a maximum expenditure of five hundred (\$500.00) dollars. All printing shall be completed on or before September 15, 1982.
