

ORDINANCE 80-3

To Amend Section 17.04.050 of the Bloomington Municipal Code, Entitled "Construction Regulations--Adoption by Reference" to Adopt the Indiana Energy Conservation Rules and Regulations for New Building Construction

SECTION I. Section 17.04.050 of the Bloomington Municipal Code, entitled "Construction Regulations--Adoption by Reference" shall be amended to read as follows:

17.04.050 Adoption by Reference. The following codes, standards, rules and regulations and amendments thereto as adopted by the State of Indiana are a part of this title as if fully set out herein and two copies shall be kept on file in the office of the city clerk for public inspection:

- (a) Uniform Building Code, 1976 Edition, International Conference of Building Officials, and Amendments as adopted by the State of Indiana.
- (b) Uniform Mechanical Code, 1976 Edition, International Conference of Building Officials, and Amendments as adopted by the State of Indiana.
- (c) Uniform Plumbing Code, 1976 Edition, International Conference of Plumbing Officials, and Mechanical Officials, and Amendments as adopted by the State of Indiana.
- (d) National Electric Code, 1978 Edition, National Fire Protection Association, and Amendments as adopted by the State of Indiana.
- (e) One and Two Family Dwelling Code, 1975 Edition, International Conference of Building Officials, and Amendments as adopted by the State of Indiana.
- (f) Energy Conservation Rules and Regulations for New Building Construction, 1979 Edition, the Administrative Building Council, and Amendments as adopted by the State of Indiana.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
