

ORDINANCE 80-16

To Designate Lamp Posts on
South Hawthorne Drive as Historic

WHEREAS, Section 20.09.03.00 of the Bloomington Municipal Code permits the Common Council to officially designate buildings, structures, or districts as "historic", and

WHEREAS, the City Plan Commission, upon advice of the Historic District and Buildings Study Committee and the Elm Heights Neighborhood Association, has recommended designation of certain structures as "historic", HP-57-79,

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Twenty lamp posts on Hawthorne Drive be designated as historic within the City of Bloomington, Indiana. The property is located on the incorporated map number 6 of June 7, 1978, described as follows, to-wit:

The public right-of-way of Hawthorne Drive between Third Street and Second Street.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.


SYNOPSIS
