## ORDINANCE 80-33

## To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, ZO-13-80, and recommended that the petitioner, D. Gene Rubeck, be granted an amendment to the Bloomington zoning maps and request that the Common Council consider their petition for rezoning of certain property:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 that the zoning be changed from BL to RH

for property located at the southeast corner of Henderson Street & Winslow Road more particularly described as:

A part of the North one half of the Northeast quarter of section 16, Township No 8 North, Range 1 West in Monroe County, Indiana, and being more particularly described as follows, to wit: Beginning

A part of the North one half of the Northeast quarter of Section 16, Township No North, Range 1 West in Monroe County, Indiana, and being more particularly described as follows, to wit: Beginning at the Northwest corner of said Northeast quarter; thence with the North line of said Northeast quarter N 89°47'15" E., 646.06 feet, to the Northwest corner of Sherwood Green Phase I; thence with the West line of said Sherwood Green Phase I, S 00°29'45" E., 601.32 feet, thence S. 85°25'27" W., 53.45 feet; thence S. 85°28'10" W., 594.50 feet, to a Point on the West line of said Northeast quarter; thence with the West line of said Northeast quarter N. 00°28'15" W., 650.15 feet, to the Point of Beginning. Containing 9.28 acres, more or less, a part of the North one-half of the Northeast Quarter of Section 16, Township 18 North, Range 1 West in Monroe County, Indiana, more particularly described as follows, to wit, beginning at the Northwest Corner of said Northeast Quarter; thence with the North Line of Said Northeast Quarter N 89 degrees 47' 15" E., 646.06 feet, to the Northwest Corner of Sherwood Green Phase 1 and the Real Point of Beginning; Thence continuing N 89 degrees 47' 15" E 140 feet more or less, thence S 00 degrees 29' 45" E 440 feet more or less, thence S89 degrees 47'15" W for 140 feet, thence N 0 degrees 29'45" W for 440 feet and to the Point of Beginning, containing 1.4 acres more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
