## ORDINANCE 80-40

To Amend the Bloomington Zoning Maps, Dated June 7, 1978

- WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and
- WHEREAS, the Bloomington Zoning Maps have been amended to designate the property described below as a Planned Unit Development on June 15, 1978; and
- WHEREAS, the Common Council, upon the recommendation of the Plan Commission, has has approved Outline plans for development of the property; and
- WHEREAS, the Plan Commission has considered the request of Meadowood I.U. Retirement Community (PUD-16-80) that the Outline Plan be amended to eliminate the passing blister at the access to Dunn Street, and recommended that the plan be so amended;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. That a revised outline plan, eliminating the passing blister of the Dunn Street Access be approved for the property described as:

Access be approved for the property described A part of the East half of the Northeast quarter of Section 28, Township 9 North, Range 1 West, Honroe County, Indiana, described as follows: Beginning at the Northeast corner of said Northeast quarter, thence N88°-10'-40'W (assumed bearing) over and along the North line of said East half of the Northeast quarter for a distance of 1309.51 feet to the Northwest corner of said half-quarter, thence 500°-16'-33'W over and along the West line of said half-quarter for a distance of 513.67 feet, thence East for a distance of 182.06 feet, thence S3°-51'-12'E for a distance of 308.91 feet, thence S13°-51'-55'E for a distance of 323.01 feet, thence S13°-51'-55'E for a distance of 240.85 feet, thence S10°-16'-33'W for a distance of 429.88 feet, thence East for a distance of for a distance of 1448.89 feet to the place of beginning. Containing 30.00 acres, more or less together with necessary easements or rights of way for ingress, egress, or utilities over adjacent properties owned by Indiane University Foundation.

ALSO, Lot No. 3 in North Dunn Addition, Monroe County, Indiana, excepting therefrom the following described real estate: Beginning at the Northwest corner of the said Lot No. 3, said point being in the center line of North Dunn Street, thence East for a distance of 394.65 feet, thence South 1 degree 56 minutes West for a distance of 148 feet, thence West for a distance of 389.65 feet, and to the center line of North Dunn Street, thence Korth, over and along the center line of North Dunn Street, for a distance of 148 feet and to the place of beginning, containing after said exception 4.69 acres, more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
