To Amend Chapter 6.08 of the Bloomington Municipal Code, Entitled "Cemeteries and Burials"

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Subsection (9) of Section 6.08.010 of the Bloomington Municipal Code shall be amended to read as follows:

(9) No burials shall be allowed on Sundays or holidays.

SECTION II. Subsection (10) of Section 6.08.010 of the Bloomington Municipal Code shall be deleted.

SECTION III. Subsection (12) of Section 6.08.010 of the Bloomington Municipal Code shall be amended to read as follows:

(12) Rosehill Cemetery gates on Fifth Street shall be closed at all times. Rosehill Cemetery gates on Fourth Street shall be open at all times.

SECTION IV. Section 6.08.020 of the Bloomington Municipal Code, entitled "Payment of Charges and fees", shall be amended to read as follows:

6.08.040 Payment of fees. All grave space fees and interment fees shall be paid to the sexton of Rosehill Cemetery prior to the time the body is interred.

SECTION V. Section 6.08.040 of the Bloomington Municipal Code, entitled "Charge for one-grave section", shall be amended to read as follows:

<u>6.08.040</u> Fees for purchase of grave spaces. (a) For each space sold in Rosehill Cemetery, the fee shall be as follows:

- For each adult grave space the fee shall be one hundred seventy dollars (\$170).
- (2) For each infant grave space the fee shall be twenty five dollars (\$25).
- (3) For each grave space for the interment of ashes the fee shall be fifty dollars (\$50).

(b) In addition, a county recording fee of four dollars and fifty cents (\$4.50) shall be paid to the sexton at the time the space is purchased.

SECTION VI. Section 6.08.050 of the Bloomington Municipal Code, entitled "Charge for six-grave section", shall be deleted and a new Section 6.08.050 shall be added to read as follows:

<u>6.08.050 Welfare grave spaces</u>. There shall be no charge for grave spaces for welfare burials.

SECTION VII. Section 6.08.070, entitled "Interment charges," shall be amended to read as follows:

6.08.070 Interment fees. The fees for interment shall be as follows:

- (1) The fee for interment of ashes shall be fifty dollars (\$50).
- (2) The fee for interment of the remains of infants shall be thirty-five dollars (\$35).
- (3) The fee for interment of the remains of children shall be eighty dollars (\$80).
- (4) The fee for the interment of the remains of adults shall be one hundred forty dollars (\$140).

SECTION VIII. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
