ORDINANCE 80-55

To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, PCD-23-80, and recommended that the petitioner, KILLION BLDG. SERVICE, be granted an amendment to the Bloomington zoning maps and request that the Common Council consider their petition for rezoning of certain property: 700 N. Walnut Street, Bloomington, IN

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 that the PCD designation on the site be deleted for property located at 700 North Walnut Street (N.E. corner Walnut & Cottage Grove) more particularly described as:

Lot 1, Lade's Addition to the City of Bloomington

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
