## ORDINANCE 80-65

To Amend Sections 15.76.010, entitled "Stop Intersections", 15.64.370 entitled "Restricted Parking Zones" and 15.64.410 entitled "No Parking Zones" of the Bloomington Municipal Code.

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.76.010(1) of the Bloomington Municipal Code, entitled "Stop Intersections - Generally," shall be amended to add the following:

Second Street at Swain Avenue

SECTION II. Section 15.64.370(4) of the Bloomington Municipal Code, entitled "Restricted parking zones - Two-hour parking zones", shall be amended to add the following:

South Rose Avenue, west side of 400 block

SECTION III. Section 15.64.410 of the Bloomington Municipal Code, entitled "No Parking Zones", shall be amended to add the following:

East side of 600 block of South Rogers Street in front of 649 South Rogers

South side of 200 block of West Fourth Street

Both sides of Pete Ellis Drive from Longview Drive north to State Road 45.

SECTION IV. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
