

ORDINANCE 80-66

To Amend and Repeal Various Sections of Chapter 15.64  
of the Bloomington Municipal Code Regarding Loading Zones

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,  
MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.64.280 of the Bloomington Municipal Code, entitled  
"Loading zones--Establishment", shall be amended to read as follows:

15.64.280 Loading zones. (a) The common council, by ordinance, shall  
determine the location of loading zones and shall order the placing and main-  
taining of appropriate signs indicating them. Loading zones shall be in effect  
twenty-four hours a day, seven days a week.

(b) Trucks and passenger vehicles may use the loading zones without charge.  
Passenger vehicles shall be limited to a maximum of five minutes use to load and  
unload passengers and trucks shall be limited to a maximum of thirty minutes use  
to deliver and pick up materials.

(c) In addition to the loading zones designated below, all alleys may be  
used as loading zones subject to the limitations in subsection (b), but it shall not  
be necessary to erect signs to this effect. Loading zones shall be located at:

124 North Walnut Street.  
210 North Walnut Street.  
226 North Walnut Street.  
100 and 211 North Washington Street.  
110 East Kirkwood Avenue.  
Gentry Ave., half block north of the east-west alley on east side.  
100 South College Avenue, first space on west side.  
200 East Sixth Street, first space east of Washington Street  
on south side.  
200 North College, second space north of Sixth Street on west side.


SECTION II. Sections 15.64.290, entitled "Loading zones", 15.64.300, entitled  
"Passenger curb loading zones", and 15.64.310, entitled "Freight curb loading zones",  
shall be repealed.

SECTION III. This ordinance shall be in full force and effect from and after  
its passage by the Common Council and approval by the Mayor.




