

ORDINANCE NO. 79-7

AN ORDINANCE TO AMEND TITLE 15 OF
THE BLOOMINGTON MUNICIPAL CODE BY
AMENDING SECTION 15.64.410 ENTITLED,
"NO PARKING ZONES"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,
INDIANA, THAT:

SECTION 1. Section 15.64.410 of the Bloomington Municipal
Code, entitled, "No Parking Zones", hereby amended by adding thereto
the following:

The East side of the two hundred block
of South Jordan from East Third Street
North for a distance of 150 feet shall
be designated as a No Parking Zone.

The West side of Walnut Street from 1724 South
Walnut South to Country Club Drive shall be
designated as a No Parking Zone.

SECTION 2. That this Ordinance shall be in full force and
effect from and after its passage and signature in accordance with
the law.

SYNOPSIS

ORDINANCE NO. 79-7

The City of Bloomington has power to make laws regarding certain aspects of parking and traffic control on its streets, and these are collected in the "Vehicles and Traffic" sections of the Bloomington Municipal Code. Consequently when parking, speed zone, or sign changes are found to be required by the Traffic Commission or other member of the City Administration, the Council must amend the code to incorporate the changes.

This ordinance makes changes in the following;

No Parking Zones:

The East side of the two hundred block of South Jordan from East Third Street North for a distance of 150 feet shall be designated as a No Parking Zone.

The West side of Walnut Street from 1724 South Walnut south to Country Club Drive shall be designated as a No Parking Zone.
