ORDINANCE **#79-27**

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAPS, DATED JUNE 7, 1978

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978, and

WHEREAS, said Zoning Ordinance and maps are now incorporated in the Bloomington Municipal Code as Title 20 of said Code, and

WHEREAS, the City Plan Commission has considered this case, ZO-17-79 and recommended said Bloomington zoning maps be amended by the rezoning of certain property, and WHEREAS, the petitioner, DANNY & JOYCE SHIELDS, requests that the Common Council of the City of Bloomington consider this petition for the rezoning of said property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, that the authority of Chapter 174 of the 1947 Acts of the General Assembly of the State of Indiana, as amended, that the zoning on property located at 2801 S. Rogers St. (SE corner of Rogers and Country Club Rd.) be changed from RS-Single Dwelling Residential District to BG-General Commercial District.

SECTION 1. That the Bloomington Zoning Map of June 7, 1978 be amended to rezone the following described land as follows, to-wit:

That part of the Northeast quarter of the Northeast quarter of Section Seventeen (17), Township eight (8) North, range one (1) West in Monroe County, Indiana, more particularly described as follows:

Beginning at a point on the center line of Rogers Street Pike Road said point being 619.0 feet West and 148.32 feet south of the Northeast corner of said quarter quarter section; thence North one (1) degree, zero (0) minutes, thirty (30) seconds East along the center line of South Rogers Street Pike Road for a distance of 148.32 ft. to its intersection with the North line of the said quarter quarter section, said point being also the center of Country Club Drive; thence East along the said North line and the center line of Country Club Drive for a distance of 125.0 feet; thence South one (1) degree, two (2) minutes West for a distance of 146.86 feet; thence South eight-nine (89) degrees, sixteen (16) minutes, thirty (30) seconds West for a distance of 125.0 feet to the place of beginning.

A strip of land fifteen (15) feet in width off the North side of the above described real estate is reserved for the right-of-way of South Rogers Street Pike Road.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
