

ORDINANCE 79-42

To Amend Title 15 of the Bloomington Municipal Code
by Amending Sections 15.64.080 Entitled "Parallel
Parking", 15.64.410 "No Parking Zones", 15.76.010 "Stop
Intersections", and 15.76.020 "Yield Intersections"

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.64.080 of the Bloomington Municipal Code, entitled "Parallel Parking", is amended by adding the following:

The west side of the 500 block of North Morton Street.

SECTION II. Section 15.64.410 of the Bloomington Municipal Code, entitled "No Parking Zones", is amended by adding the following:

Both sides of North Walnut Street from Bypass 45-46 north to the entrance of Blue Ridge.

Both sides of the 600 Block of North Morton from Tenth Street north to the first east-west alley.

SECTION III. Section 15.76.010(1) of the Bloomington Municipal Code, entitled "Stop Intersections Generally", is amended by adding the following:

Pete Ellis Drive at Longview Avenue.

SECTION IV. Section 15.76.020 of the Bloomington Municipal Code, entitled "Yield Intersections", is amended by adding the following:

Ritter Street. The traffic on Ritter Street shall yield to the traffic on Eighth Street.

Hopewell Street. The traffic on Hopewell Street shall yield to the traffic on Eighth Street.

Spring Street. The traffic on Spring Street shall yield to the traffic on Eighth Street.


Hay Street. The traffic on Hay Street shall yield to the traffic on Eighth Street.

SECTION V. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

(1) the west side of the 500 block of North Morton Street parallel parking, (2) both sides of North Walnut Street from the Bypass 45-46 north to the entrance of Blue Ridge and both sides of the 600 block of North Morton from 10th Street north to the first east/west alley no parking zones, (3) Longview Avenue stop for Pete Ellis Drive, and (4) Ritter, Hopewell, Hay and Spring Streets yield for Eighth Street.
