

ORDINANCE 79- 91

AN ORDINANCE TRANSFERRING APPROPRIATIONS WITHIN THE FEDERAL REVENUE SHARING, FLEET MAINTENANCE, GENERAL, AND PARKS AND RECREATION FUNDS OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA.


