- WHEREAS, IC 18-7-11-5 requires that city housing authorities be composed of five members, all of whom are to be appointed by the mayor; and
- WHEREAS, IC 18-7-11 et seq. prohibits tenants of housing projects under the management of city housing authorities from serving on housing authorities; and
- WHEREAS, IC 18-7-11.5 et seq. allows for the creation of boards of tenant concerns to advise the city housing authorities on matters related to the general welfare of tenants in housing projects, but such statute does not allow for these boards in Bloomington;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

The Bloomington Common Council requests its representatives to the Indiana General Assembly to support legislation to amend IC 18-7-11 et seq., Housing Authorities Act, to allow two of the five members of the authorities to be appointed by common councils and to allow tenants to serve on housing authorities, and to amend IC 18-7-11.5 et seq., Boards of Tenant Concerns in Certain Second-Class Cities, to allow these provisions to apply to the City of Bloomington.
