ORDINANCE NO. 78-//

An Ordinance to Amend the Bloomington Municipal Code Regarding Stop Intersections

The City of Bloomington has power to make laws regarding certain aspects of parking and traffic control on its streets, and these are collected in the "Vehicles and Traffic" Sections of the Bloomington Municipal Code. Consequently, when parking, speed zone, or sign changes are found to be required by the Traffic Commission or other member of the City Administration, the Council must amend the code to incorporate the changes.
