

ORDINANCE NO. 78-92

AN ORDINANCE CONCERNING THE ANNEXATION OF  
ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,  
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE  
CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the Southeast quarter of the Southwest  
quarter of Section 9, Township 8 North, Range 1  
West, Monroe County, Indiana, bounded and de-  
scribed as follows: Beginning at the Southeast  
corner of said quarter quarter; thence with the  
East line of said quarter quarter and running  
North  $01^{\circ}57'58''$  West for 246.36 feet; thence  
South  $87^{\circ}10'32''$  West for 40.00 feet and to the  
real point of beginning of this description, said  
real point of beginning being on the West right-  
of-way line of Henderson Street; thence from said  
real point of beginning and running South  $87^{\circ}10'32''$   
West for 299.50 feet; thence South  $82^{\circ}14'13''$  <sup>west</sup> for  
113.05 feet; thence North  $33^{\circ}13'20''$  West for 200.00  
feet; thence North  $36^{\circ}21'03''$  West for 40.44 feet;  
thence North  $86^{\circ}48'22''$  East for 538.68 feet and to  
the said West right-of-way line of Henderson Street;  
thence with said right-of-way line and running  
South  $01^{\circ}57'58''$  East for 200.00 feet and to the  
real point of beginning. Containing 2.19 acres,  
more or less.


SECTION 2. Be it further ordained, that the boundaries of  
the City of Bloomington shall be, and the same are, hereby declared  
to be extended so as to include all of the real estate hereinabove  
described as part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect  
from and after its passage, promulgation, approval by the Mayor  
and publication in accordance with the law.
