

RESOLUTION 78-24

TO AUTHORIZE THE MAYOR TO EXECUTE THE
CONTRACT PERTAINING TO THE URBAN MASS
TRANSPORTATION GRANT AWARDED TO THE
CITY OF BLOOMINGTON

WHEREAS, the Common Council of the City of Bloomington authorized, by Resolution 76-38, the Mayor to execute and file an application on behalf of the City of Bloomington with the U. S. Department of Transportation to aid in the financing of expenses of the City-owned Transit System, and

WHEREAS, the Common Council of the City of Bloomington did authorize by Resolution 78-10 and 78-18 the Mayor to submit an amended grant application, and


WHEREAS, the U. S. Department of Transportation has awarded the City of Bloomington a grant of \$760,628 for the purchase of four new 30-35 passenger buses, four new 19 passenger buses, two new supervisory cars, two new 5-9 passenger vans equipped for elderly and handicapped service, and the construction of a bus storage/office facility,

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:


