## RESOLUTION 78-25

To Approve the Lease Dated September 6, 1978 Between The Old Library, Incorporated, and the Monroe County Historical Society

WHEREAS, the City of Bloomington and The Old Library Incorporated (TOLI) entered into a contract and signed a deed on October 22, 1977 in which it was agreed that TOLI would not transfer, lease or assign any interest in The Old Carnegie Library (library) without prior written approval of the Common Council; and

WHEREAS, TOLI and the Monroe County Historical Society (Historical Society) signed a lease dated September 6, 1978 in which the Historical Society was granted an option on the library in the event TOLI lost or surrendered its rights to possession; and

WHEREAS, the Common Council approved in Resolution 78-7 the leasing by TOLI of space in the library to the Historical Society for the operation of a history museum but did not approve the option in the September 6, 1978 lease;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

The Common Council approves the lease dated September 6, 1978 between TOLI and the Historical Society, including the option granted to the Historical Society in Section IX of the lease to obtain possession of the library in the event that TOLI surrenders or loses its rights to possession of the library.

## SYNOPSIS

This resolution would provide Council approval of the lease between The Old Library Incorporated and the Monroe County Historical Society in which the Historical Society was given an option on the library. An earlier resolution passed by the Council included approval of a leasing arrangement between the two bodies, but did not include approval of the option.

## LEASE

THIS LEASE, made this  $b^{H}$  day of <u>September</u>, 1978, ) and between The OLD LIBRARY, INC.: MONROE COUNTY MUSEUMS, hereinafter called "TOLI" and the MONROE COUNTY HISTORICAL SOCIETY, hereinafter called "SOCIETY",

WITNESSETH:

TOLI has leased, and by these presents does grant, demise and lease unto the SOCIETY the following described premises in the City of Bloomington, Monroe County, Indiana:

1. The sole and exclusive use of these areas designated as numbers 102, 103, 105 and 106 upon the upper level and numbers 007 upon the lower level of the Old Monroe County Library Building as shown upon the attached plan.

2. The joint use, with TOLI, of the areas designated as numbers 101, 104, 107 and the area between numbers 101 and 102 and south of number 107 upon the upper level of the Old Monroe County Library as shown upon the attached plan.

I Term

The term of this lease shall be for Ten (10) years commencing when the rehabilitation of the demised premises shall be substantially complete, and TOLI shall be able to surrender possession of the demised premises to the SOCIETY.

The SOCIETY shall have the right and option to extend this lease for four (4) additional terms of Ten (10) years each under the same terms and conditions as are herein set forth, each of said extended terms to commence upon the expiration of the preceding term.

The options to extend herein granted shall be exercised by the SOCIETY by the continued occupancy of the demised premises beyond the termination dates of the original or extended terms.

## II <u>Payments</u>

The SOCIETY shall pay an annual rent of One Dollar (\$1.00). In addition the SOCIETY shall, during the term of this lease, pay 61 1/2 per cent of the cost of utilities, maintenance, and insurance. TOLI shall promptly forward to the SOCIETY a copy of all bills, invoices and statements setting out the charges, part of which are to be paid by the SOCIETY. The SOCIETY shall remit its share of such costs or charge within ten (10) days of the receipt of such copy. The SOCIETY shall provide its own janitorial service for the eas leased solely and jointly to it, and TOLI shall provide janitorial service to the remainder of the building. The SOCIETY need pay no part of the cost or expense of the janitorial service incurred by TOLI.

#### III <u>Possession</u>

IV Use

TOLI covenants that it will put the SOCIETY into possession of the described premises when the rehabilitation of the demised premises shall be substantially complete, and TOLI shall be able to surrender possession of the demised premises to the SOCIETY, and that the SOCIETY shall, during the demised term, freely, peacefully and quietly enjoy and occupy the possession of the described premises without molestation or hinderance of any person.

The SOCIETY shall use the premises for a museum and purposes associated therewith to promote and maintain interest in matters of historical significance to the residents of Monroe County, Indiana.

The SOCIETY shall conform to and observe all ordinances, rules and regulations of all public authorities, boards, or officials, and will not during the term of this lease knowingly permit the same to be used for the purpose of carrying on any illegal business or occupation.

# Repairs

The SOCIETY and TOLI mutually covenant that they will establish a sinking fund for the purpose of providing sufficient money for major repairs to the Old Monroe County Library Building. The SOCIETY shall contribute 61.5% of the money necessary to establish such a fund, and TOLI shall contribute the remaining 38.5% Payments shall be made monthly. Expenditures from the sinking fund shall not be made, except by agreement of the governing bodies of TOLI and the SOCIETY. The investment of said funds shall be the sole responsibility of TOLI.

#### VI Access

3.

The SOCIETY shall have the exclusive access to areas 102, 103, 105, 106, and 007. The SOCIETY and TOLI shall have access to those areas shared jointly by them at all times that the SOCIETY'S exclusive area shall be open to the public and at such other times as may be agreed upon.

## .VII <u>Termination</u>

In the event the SOCIETY shall fail or refuse to pay its share of the costs and expenses herein agreed to be paid, or shall fail to perform any other covenant or condition of this lease, TOLI shall deliver by certified mail notice of such default to the President and the Secrery of the SOCIETY. If such default not be cured within Ten (10) days after receipt of the notice, TOLI may at its option declare this lease terminated.

## VIII Performance by TOLI

TOLI shall fulfill all covenants, conditions and obligations of every kind required to be performed by it in order to keep and maintain its right to possession of the Old Monroe County Library Building.

#### IX Option

In the event TOLI shall default in the performance of any covenant, condition or obligation to be performed by it so as to lose its rights to possession of the Old Monroe County Library Building or in the event TOLI shall desire to surrender its rights to possession of the Old Monroe County Library Building, the SOCIETY shall have the first option to accept the obligations of TOLI and thereupon be entitled to the complete and exclusive possession of the said Old Monroe County Library Building, subject to the rights of any tenants in TOLI and subject to the deed and contract by and between TOLI and the City of Bloomington, dated October 22, 1977.


#### X <u>Alterations</u>

The SOCIETY may make any interior alterations in areas 106 and 007 in the demised premises, which alterations do not interfere with the use and occupancy by TOLI of the remainder of the structure. Structural changes in the remaining demised premises may only be made


#### DESIGN THE OLD LIBRARY
