

APPROPRIATION ORDINANCE 78-4

To Appropriate From the General Fund and the Public Works Employment Title II Fund Expenditures Not Otherwise Appropriated of the City of Bloomington, Monroe County, Indiana.

WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual budget;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. For the expenses of said municipal corporation the following additional sums of moeny are hereby appropriated and ordered set apart out of the several funds herein named and for the purpose herein specified, subject to the laws governing the same:





SYNOPSIS

Under state law, no money can be spent by the City without authorization from the Council in the form of an appropriation ordinance.

Therefore, the Board of Public Works must appropriate \$6,000 for engineering work on a pavement marking demonstration grant even though the money will be almost immediately reimbursed by the State.

The City's casualty insurance bill came in higher than budgeted because the City has not kept the insurance agent properly informed about its gross payroll. Gross payroll is the basis for the agent's determination of the amount and cost of workmen's compensation coverage and is in part the basis for the determination of general liability coverage.

Because Congressional action in September of 1977 severely limited expenditures from Local Public Works funds to "payroll related costs," the balance of that fund can be used to pay very few of the City's expenses. It may be used for workmen's compensation in which case the coverage would not affect tax rates or capital improvement monies.
