ORDINANCE 77-7

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING ORDINANCE, DATED JUNE 22, 1973

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a Zoning Ordinance on June 21, 1973, and

WHEREAS, said Zoning Ordinance establishes uses permitted in the various zones therein, and

WHEREAS, the Bloomington City Plan Commission considered and reviewed said text of the Zoning Ordinance, and

WHEREAS, the City Plan Commission, by said review, recommends that the Bloomington City Zoning Ordinance be amended as follows:

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, that under the authority of Chapter 174 of the 1947 Acts of the General Assembly of the State of Indiana as amended that the Zoning Ordinance of the City of Bloomington be amended as follows:

SECTION 1. That Section 20.07.05.00 Business A. Commercial, Retail, Item 19. Furniture and Appliances, be amended to permit said uses in the BL <u>Limited Business</u> zone. And further, that said uses be limited to a maximum of three thousand (3,000) square feet of gross floor area.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
