## ORDINANCE NO. 77-22

AN ORDINANCE TO RE-ENACT CHAPTER 12.16 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED, "PARKING PERMITS"

WHEREAS, Chapter 12.16 of the Bloomington Municipal Code, entitled "Parking Permits", expired as of December 31, 1976; and WHEREAS, the Common Council desires to examine the public policy behind such parking permits;

NOW THEREFORE BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, That:

SECTION 1. Chapter 12.16 of the Bloomington Municipal Code, entitled "Parking Permits", is hereby re-enacted in full except for the amendments contained in the succeeding sections herein.

- SECTION 2. §12.16.050 is hereby amended to read as follows:

  12.16.050 Expiration of Permits. All permits expire
  on December 31 of the year of issuance. Permits must
  be renewed by February 15 or application and permit
  expire. Except that all permits which expired on
  December 31, 1976, are hereby renewed to be in full
  force and effect through Dec. 31, 1977. All such
  permits expire at 12 a.m., Jan. 1, 1978. No other
  permits shall be issued or renewed under the authority
  of this chapter.
- SECTION 3. §12.16.060 is hereby amended to read as follows:

  12.16.060 Fees. An initial administrative fee of

  \$25.00 shall be paid upon issuance of a permit. An

  annual permit fee of \$26.00 shall be paid thereafter

  (\$13.00 after July 1). Except that no fee shall be

  paid for renewal of permits which expired on December

  31, 1976, as provided for in §12.16.050.
- SECTION 4. §12.16.100 is hereby amended to read as follows:

  12.16.100 Enforcement. No vehicle other than those authorized by the applicable permit shall park in a private parking space designated by a sign with a decal as provided for in §12.16.040.

SECTION 5. §12.16.120 is hereby amended to read as follows: 12.16.120 Expiration. This Chapter shall expire at 12a.m., Jan. 1, 1978.

SECTION 6. This Ordinance shall be in full force and effect from and after its passage and promulgation by the Common Council and approval by the Mayor. PASED AND ADOPTED this 14 day of March, 1977.
