

ORDINANCE NO. 77-64

AN ORDINANCE TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE BY AMENDING SECTIONS 15.64.410, ENTITLED, "NO PARKING ZONES" AND 15.76.010, ENTITLED, "STOP INTERSECTIONS"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.64.410, entitled, "No Parking Zones", be amended by adding thereto the following:

1. The 700, 800, and 900 blocks of East 13th Street on the South side of the street shall be designated as No Parking Zones.
2. The 700, 800, and 900 blocks of East 14th Street on the North side of the street shall be designated as No Parking Zones.
3. The 1000 block of North Woodlawn on the West side of the street shall be designated as a No Parking Zone.
4. The 200 block of North Elm Street on the West side of the street shall be designated as a No Parking Zone.
5. The 400 block of North Jackson Street on the West side of the street shall be designated as a No Parking Zone.

SECTION 2. That Section 15.76.010, entitled, "Stop Intersections", be amended by adding thereto the following:


1. West bound Gifford Road shall be designated Stop for Park Drive and North bound Gifford Road. This ordinance repeals any previous ordinance pertaining to this location.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and signature in accordance with the law.

SYNOPSIS

Ordinance No. 77-64

An Ordinance to Amend the Bloomington
Municipal Code Title 15, Sections
15.64.410, Entitled, "No Parking Zones",
and 15.76.010, Entitled, "Stop Intersections"

The City of Bloomington has power to make laws regarding certain aspects of parking and traffic control on its streets and these are collected in the "Vehicles and Traffic" sections of the Bloomington Municipal Code. Consequently when parking, speed zone, or sign changes are found to be required by the Traffic Commission or other member of the City Administration, the Council must amend the code to incorporate the changes.

This ordinance makes changes in "No Parking Zones", and "Stop Intersections":

1. 700, 800, and 900 blocks of East 13th Street on South Side shall be designated as No Parking Zones.
2. 700, 800, and 900 blocks of East 14th Street on North side of Street shall be designated as No Parking Zones.
3. 1000 block of North Woodlawn on the West side of the Street shall be designated as a No Parking Zone.
4. 200 block of North Elm Street on the West side of the street shall be designated as a No Parking Zone.
5. 400 block of North Jackson Street on the East side of of the street shall be designated as a No Parking Zone.

Stop Intersection:


1. West bound Gifford Road shall be designated Stop for Park Drive and North Bound Gifford Road.
