### ORDINANCE NO. 77-94-

### AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

> A part of the southwest quarter of Section 11, Township 8 North, Range 1 West, Monroe County, Indiana, described as follows: Beginning at the Northwest corner of said southwest quarter; thence south 00°06'30" west over and along the west line of said southwest quarter for a distance of 970.60 feet; thence south 86°30'30" east for a distance of 433.47 feet to the real point of beginning; thence continuing south 86°30'30" east for a distance 230.16 feet to the centerline of Sare Road; thence south 00°49'30" east over and along the centerline of said Sare Road for a distance of 215.68 feet; thence North 86°30'30" West for a distance of 230.16 feet; thence North 00°49'30" West for a distance of 215.68 feet to the real point of beginning, containing 49,500 square feet (1.136 acre, more or less).

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
