

ORDINANCE NO. 77-96

AN ORDINANCE CONCERNING THE ANNEXATION OF  
ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,  
is adjacent to the real estate described herein,

NOW, THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE  
CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the  
same is, hereby annexed to and declared a part of the City of  
Bloomington, Indiana, to-wit:

A part of the Southwest quarter of the Southeast  
quarter of Section 9, Township 8 North, Range 1  
West, in Monroe County, Indiana, bounded and de-  
scribed as follows to-wit: Beginning at a point  
that is 491 feet East of the Northwest corner of  
the Southwest quarter of the Southeast quarter of  
said Section; thence running South 1320 feet to  
the South line of said Section 9; thence East 429  
feet; thence North 1320 feet to the North line of  
said section; thence West 429 feet and to place  
of beginning, containing 13 acres.

SECTION 2. Be it further ordained, that the boundaries  
of the City of Bloomington shall be, and the same are, hereby  
declared to be extended so as to include all of the real estate  
hereinabove described as part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect  
from and after its passage, promulgation, approval by the Mayor  
and publication in accordance with the law.

ORDINANCE 77-96
