- WHEREAS, long periods of winter cold have resulted in frozen water pipes in many Bloomington homes, and
- WHEREAS, in response to this situation, the Utilities Department has asked that residents of the City of Bloomington leave water faucets running to reduce the potential for frozen pipes,

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA THAT:

- SECTION I. The Common Council of the City of Bloomington approves the recommendation of the Utility Service Board that residential water customers be billed according to their January and February 1976 amounts of water usage for the months of January and February, 1977.
- SECTION II. Any individual who feels that their water rates warrant additional adjustment may appeal to the Utility Service Board's Appeal Committee as set out in Section X of the Utility Rules and Regulations.
- SECTION III. This resolution shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
