APPROPRIATION ORDINANCE 77-12

AN ORDINANCE SPECIALLY APPROPRIATING FROM
THE PARKS AND RECREATION FUND EXPENDITURES
NOT OTHERWISE APPROPRIATED OF THE CITY OF
BLOOMINGTON, MONROE COUNTY, INDIANA

WHEREAS, it has been determined that it is now necessary to
appropriate more money than was appropriated in the annual budget,
now, therefore:

SECTION 1. BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY
OF BLOOMINGTON OF MONROE COUNTY, INDIANA, THAT FOR THE EXPENSES OF
SAID MUNICIPAL CORPORATION THE FOLLOWING ADDITIONAL SUMS OF MONEY
ARE HEREBY APPROPRIATED AND ORDERED SET APART OUT OF THE SEVERAL
FUNDS HEREIN NAMED AND FOR THE PURPOSES HEREIN SPECIFIED, SUBJECT
TO THE LAWS GOVERNING THE SAME:
