ORDINANCE 75-2

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION L. That from and after the first day of January, 1975, the salary and pay schedule for the following appointed officers and employees of the City of Bloomington, be fixed as follows

I, the undersigned, Francis X. Custodian-----\$3.00 an hour


8. HOUSING AUTHORITY


