

ORDINANCE NO. 75-5

AN ORDINANCE TO AMEND CHAPTER 15.76 OF THE
BLOOMINGTON MUNICIPAL CODE SECTION 15.76.010(2)
ENTITLED, "STOP INTERSECTIONS-FOUR WAY"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF
BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.76.010(2) of the Bloomington
Municipal Code, entitled, "Stop Intersections-4 Way" be amended
by adding thereto the following:


"The intersections of College Mall Road,
driveway to Eastland Plaza and driveway
to Sears lot shall be designated a 4-way
stop intersection."

SECTION 2. That this ordinance shall be in full force and
effect from and after its passage, promulgation and publication
in accordance with the law.

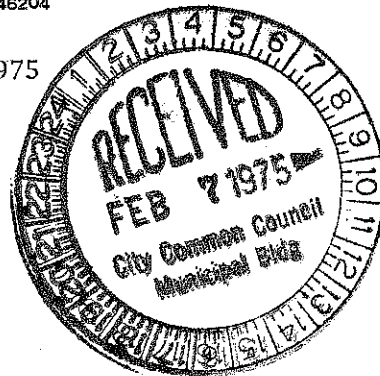
