AN ORDINANCE TO AMEND CHAPTER 15.64 OF  
THE BLOOMINGTON MUNICIPAL CODE, SECTION  
15.64.410, ENTITLED, "NO PARKING ZONES."


BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF  
BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.64.410 of the Bloomington  
Municipal Code be amended by deleting therefrom the following  
location:


"Faculty Avenue, east side, from Third  
Street South to the first alley running  
east and west."

effect from and after its passage, promulgation and publication  
in accordance with the law.



In accordance with Section 15.64.080 of the Bloomington Municipal Code: for a period of 90 days beginning February 25, 1975, the following shall be in effect:

15.64.150 PARALLEL PARKING

Faculty Street from 3rd Street south to the first alley running east and west on the east side of the street shall be designated as an unlimited time parking zone.
