ORDINANCE NO. 75-30

AN ORDINANCE TO AMEND THE BLOOMINGTON  
ZONING MAPS, DATED JUNE 22, 1973

WHEREAS, the Common Council of the City of Bloomington, Indiana passed a zoning ordinance amendment and adopted new incorporated zoning maps of June 21, 1973, and

WHEREAS, said zoning ordinance and maps are now incorporated in the "Bloomington Municipal Code" as Title 20 of said Code, and

WHEREAS, the City Plan Commission has recommended said Bloomington Zoning Maps be amended by the rezoning of certain property.


NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA AND ALL ACTS SUPPLEMENTARY AND AMENDATORY THERETO:

SECTION 1. That the incorporated map number 9, of June 22, 1973, be amended to designate the following described land in the City of Bloomington, Monroe County, Indiana as a BL/PUD-Planned Commercial Development, to-wit:


A part of the Northwest quarter of Section 1, T8N, R1W, Monroe County, Indiana described as follows: Beginning at the Northeast corner of said Northwest quarter of Section 1, thence South for a distance of 600 feet, thence West for a distance of 360 feet, thence North for a distance of 600 feet, thence East for a distance of 360 feet to the place of beginning. Containing 5 acres, more or less.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Passed and adopted by the Common Council of the City of Bloomington, Indiana on 5th day of June, 1975.


