

ORDINANCE 75-49

AN ORDINANCE TO AMEND THE BLOOMINGTON MUNICIPAL  
CODE CHAPTER 17.12, SECTION 17.12.140,  
EXCEPTIONS TO LICENSING REQUIREMENTS

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY  
OF BLOOMINGTON, MONROE COUNTY, INDIANA:

SECTION 1. That Section 17.12.140 of the Bloomington  
Municipal Code, entitled "Exceptions to Licensing Requirements"  
be amended to read as follows:

17.12.140 Exceptions to Licensing Requirements. All  
electrical installations within the corporate limits and the  
two (2) mile fringe of the city shall be made by an electrical  
contractor licensed under this chapter, except than any person  
may maintain and upgrade the electrical wiring of any single  
family dwelling unit owned and maintained by him, so long as  
the work thus done meets the inspection requirements of this  
chapter.

The licensing provisions of this chapter shall not apply  
to any person or the employees of any firm when such person  
or firm is not related to the business of electrical con-  
tracting, but employs personnel and maintains an electrical  
service department to perform electrical service work to  
repair electric wiring upon his or its own property. (Ord.  
73-42 12, 1973; Ord 66-41 11, 1966).

SECTION 2. This Ordinance shall be in full force and  
effect from and after its passage, promulgation and publi-  
cation in accordance with the law.
