

ORDINANCE 75-74

SALARY ORDINANCE FOR APPOINTED OFFICERS AND EMPLOYEES

AN ORDINANCE FIXING THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF BLOOMINGTON, INDIANA FOR THE YEAR 1976.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION I. That from and after the first day of January, 1976, the salary and pay schedule of the following appointed officers and employees of the City of Bloomington, be fixed as follows:

TO THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON:

I, the undersigned, Francis X. 


SECTION II. The rates shown as wages and salaries for the positions listed above are maximum rates.

SECTION III. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approved by the Mayor.


