SALARY ORDINANCE FOR APPOINTED OFFICIALS AND EMPLOYEES

AN ORDINANCE FIXING THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF BLOOMINGTON, INDIANA FOR THE YEAR 1976, FUNDED UNDER THE COMPREHENSIVE EMPLOYMENT AND TRAINING ACT.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:



SECTION III: This ordinance shall be in full force and effect from and after its passage by the Common Council and approved by the Mayor.




