(5) the reduction of the isolation of income groups within communities and geographical areas and the promotion of an increase in the diversity and vitality of neighborhoods through the spatial deconcentration of housing opportunities for persons of lower income and the revitalization of deteriorating or deteriorated neighborhoods to attract persons of higher income; and,

WHEREAS, THE FIRST YEAR SUMMARY BUDGET PREPARED FOR THE MAYOR BY THE WORKABLE PROGRAM COMMITTEE MEETS THE LOCAL AND NATIONAL OBJECTIVES OF THE PROGRAM AND THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974.
