

RESOLUTION 75-20

A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF BLOOMINGTON TO CERTIFY THE SIGNATURES OF CITY OFFICIALS TO DRAW ON THE LETTER OF CREDIT FOR COMMUNITY DEVELOPMENT BLOCK GRANT NO. B-75-HN-18-0002.

WHEREAS, the City of Bloomington, Indiana is entitled to the sum of \$1,004,000.00 as a Non-Metropolitan Entitlement City (Sec. 106) under the provisions of Title I of the Housing and Community Development Act of 1974 (Public Law 93-383); and,

WHEREAS, the City of Bloomington, having submitted Grant No. B-75-HN-18-0002, is bound by the requirements of fiscal management procedures of Federal Management Circular 74-4, prepared by the General Services Administration; and,

WHEREAS, the regulations of the Department of Housing and Urban Development, 24 CFR Part 570, and the General Services Administration, FMC 74-4, require the submission of Standard Form 1194 (signature card) with accompanying authorizing resolution of the governing legislative body prior to the utilization of the Letter of Credit.






